TESTIMONY SENATOR JOANNE C. BENSON SB688-PUBLIC WORKS CONTRACTS APPRENTICESHIP REQUIREMENTS (MARYLAND WORKFORCE APPRENTICESHIP UTLIZATION ACT)

Employers who utilize apprentices report a 36% return on investment due to increased productivity and reduced recruitment costs.

Additionally, the immediate benefits for apprentices have the potential to create long-term positive outcomes for our state. By investing in the future of our workforce, we are not only helping individuals achieve their full potential but also ensuring that Maryland remains competitive in an increasingly global economy. The investment in our workforce will lead to a more prosperous and equitable society for all. According to the U.S. Department of Labor, apprenticeship programs contribute significantly to higher area rates of employment and wage growth.
