Senate Finance Committee March 11, 2025 Senate Bill 1005 – Federally Qualified Health Centers Grant Program – Acquisition of Land **POSITION: SUPPORT**

The Mid-Atlantic Association of Community Health Centers (MACHC) is the federally designated Primary Care Association for Delaware and Maryland Community Health Centers. As the backbone of the primary care safety net, Federally Qualified Health Centers (FQHCs) are united by a shared mission to ensure access to high-quality health care to all individuals, regardless of ability to pay. FQHCs are non-profit organizations providing comprehensive primary care to the medically underserved and uninsured. MACHC supports its members in the delivery of accessible, affordable, cost effective, and quality primary health care to those most in need. To this end, MACHC supports Senate Bill 1005.

Senate Bill 1005 enhances the flexibility of the Federally Qualified Health Centers Capital Grant Program to assist in meeting the health care needs of medically underserved communities. If enacted, the State will be authorized to provide grants to counties, municipal corporations, and nonprofit corporations for the acquisition of land for the construction or use of a FQHC. This additional flexibility will enable FQHCs and local jurisdictions to purchase land to build a new facility, which may be necessary if there is no existing buildings that could be utilized to open or expand a clinic.

Expanding the program to allow for the acquisition of land enhances the flexibility of the grant program but does not increase funding, and therefore there are no fiscal implications. However, expanding the program as proposed will enhance the ability of the State, local jurisdictions, and FQHCs to provide health care services to Maryland's most disadvantaged populations. A favorable report is requested on Senate Bill 1005.

GBMS through its location in Capitol Heights, Maryland serves approximately 12,000 Maryland residents within that region. Even with GBMS' operations this region experiences a persistent and expansive unmet healthcare need among its residents. This has prompted Greater Baden Medical services to build a new location in Capitol Heights that will drastically expand service capacity. This new location will allow GBMS to hire an additional 20 healthcare clinicians and serve 30,000 more patients. All while keeping the current Capitol Heights location open.

GBMS is a nonprofit which relies on public funding, Medicaid and Medicare reimbursements, and donations to operate and grow to meet healthcare needs. Additionally, FQHCs are mandated by the Federal government to serve patients who are uninsured and do not have the means to pay for healthcare. When FQHCs like GBMS face seek to undergo capital projects, the process to secure adequate financing can be onerous and cost prohibitive. As the law is currently written, the Federally Qualified Health Center Grant fund does not allow for FQHC's to use this funding for land acquisition.

Senate Bill 1005 will provide much-needed flexibility and certainty for FQHCs like GBMS to access public funds for land acquisition, enabling them to secure property in areas where they can build new health centers. Specifically, for GBMS Senate Bill 1005 enactment will maintain the financial viability for their proposed Capitol Heights facility.

I humbly urge the Finance Committee to give this bill a favorable report and support its passage, as it will make a significant difference in FQHC's ability to provide high quality healthcare to Maryland's most vulnerable populations.

The Maryland Community Health System (MCHS) supports Senate Bill 1005 - *Federally Qualified Health Centers Grant Program - Acquisition of Land*. The bill would allow the Federally Qualified Health Centers Capital Grant Program to make grants to counties, municipal corporations, and nonprofit corporations for the acquisition of land for the construction or use of a federally qualified health center.

The Maryland Community Health System is a network of federally qualified health centers (FQHC) located across Maryland. FQHCs are vital for communities lacking access to healthcare. They offer primary care, dental services, and mental health counseling. These centers focus on low-income and marginalized populations, ensuring equitable access to health services. In Maryland, FQHCs improve lives through comprehensive care and preventive services. Currently, the FQHC Grant Program which is under the Department of Health, only provides capital grants to assist in the conversion, acquisition, design, construction, renovation, and equipping of Federally Qualified Health Center facilities.

The bill would provide more flexibility in the FQHC Grant Program. The Maryland Department of Health could consider funding land acquisition if in the best interests of the community. The additional flexibility is particularly important in rural communities where there may be fewer options for existing buildings. An FQHC might have to purchase land to build a new clinic site.
