- Motor Coordination Challenges: Able to walk but has imbalance
- Seizure Disorder: Under medication to manage seizures

# Current Support & Services:

- Receives Occupational Therapy (OT), Physical Therapy (PT), and Speech Therapy (ST) multiple times per week.
- Although Kangyi Lee is not yet participating in the Maryland Developmental Disabilities Administration (DDA) Self-Directed Services (SDS) program due to his age, his family recognizes the importance of this program for his future care needs.

# Why Self-Directed Services (SDS) Matters:

Self-Directed Services (SDS) under the DDA program allows individuals with disabilities and their families to have more control over their care, enabling them to choose services that best fit their needs.

For Kangyi Lee, SDS provides:

- Personalized Care: Ensures he receives therapies and support tailored to his unique medical and developmental challenges.
- Flexibility: Allows his family to hire qualified caregivers who understand his condition and needs.
- Enhanced Quality of Life: Provides structured engagement opportunities and specialized services essential for his development and well-being.
- Safety and Stability: Helps manage his medical conditions with appropriate support, reducing risks related to swallowing and seizures.

Kangyi Lee and his family have significant concerns about the ongoing budget cuts to Maryland's DDA-SDS program. These reductions threaten his future access to vital services that support his health, development, and overall well-being. Without sufficient funding, his family may struggle to provide the necessary care and support he requires daily.
