Some information has been redacted because it is not responsive to your request (serial numbers and gift card information), and GP \S 4-352 (Records Relating to Public Security) which relates to the storage location of the weapons. Regarding the request for information about firearms entered (or to be entered) into the ATFE Crime Gun System, the information is being withheld under 18 U.S.C.A. \S 923(g) and the Tiahrt amendment as applied via \S 4-301 (a)(2)(ii) where, by law , the public record is privileged or confidential based on a federal statute or regulation. You may seek judicial review of the City's decision, pursuant to \S 4-362 of the General Provisions Article of the Annotated Code of Maryland.
