Support In Concept

The Office of Attorney General (OAG) supports the intent of **Senate Bill 7**, Senator Michael Jackson's legislation to raise awareness of child exploitation and human trafficking amongst transportation sector employees and contractors.

According to the National Human Trafficking Hotline, "[s]ex trafficking occurs at truck stops in the United States often into forms, through commercial sex and through fake massage businesses." Similarly, according to the American Association of Airport Executives, "[t]he first step in combating human trafficking is learning to spot warning signs, and travel industry employees should participate in training seminars tailored to them. Airport, airline, and security personnel who have completed human trafficking awareness training is a vital first line of defense in the effort to prevent this crime." Senate Bill 7 can greatly heighten awareness and, through associated reporting, improve public safety.

While the OAG supports the intent of Senate Bill 7, we have concerns about the implementation of the bill.

Senate Bill 7 contains several ambiguities, including the description of the individuals and entities in subsection (b) to whom the bill applies, as well as the responsibilities of the Maryland Department of Transportation (MDOT), MDOT modal administrations, and State contractors regarding training, certifications, policies, reporting procedures, and reports under subsections (c)-(e). There is also uncertainty about whether the training requirements and immunity provisions in subsections (c)-(f) are applicable to all MDOT and contractor employees or only those identified in subsection (b). Additionally, the term "designated regional navigator" is not defined in subsection (e), leading to further confusion. Lastly, there are concerns surrounding the potentially overbroad immunity provisions in subsection (f) and their compatibility with the Tort Claims Act, particularly regarding the extension of immunity to the State rather than just individual employees or private entities.

While recognizing our concerns, we support the intent of this legislation. The OAG respectfully urges the Committee to issue a favorable report on **Senate Bill 7**.

Senate Bill 0007 requires the Department of Transportation to develop and implement a training program for transportation sector employees on the identification and reporting of suspected human trafficking victims. This is a critical step forward in addressing the pervasive issue of human trafficking, which disproportionately impacts women and girls, particularly from marginalized communities.

By mandating the Maryland Department of Transportation to create a training program for transportation employees, SB0007 ensures that those with public-facing and high-traffic roles —such as drivers, station personnel, and security staff—are not only aware of the signs of trafficking but also understand their legal and ethical obligations to intervene and report. The requirement for training to be completed annually and within 90 days of hiring ensures that the workforce remains vigilant and educated on the latest methods of trafficking, which frequently evolve. Furthermore, SB0007 removes civil and criminal liability for reporting suspected trafficking, which provides critical legal protection for those who take action in good faith, ensuring that employees are not deterred by fear of repercussions.

Engagement at truck stops is a good example of how DoT employees can reduce the likelihood that vulnerable individuals, including runaway children, become easy targets for trafficking. These locations offer a degree of privacy, making it easier for traffickers to exploit their victims. While the majority of the trucking industry is not involved in sex trafficking, there are consumers who drive this illicit trade.

This bill addresses these alarming practices by mandating training for those working in the transportation sector to help them identify, report, and prevent human trafficking. SB0007 recognizes the structural power imbalances that allow trafficking to flourish and seeks to empower ordinary citizens—specifically those working in transportation—to be proactive agents in combating this common form of gender-based violence. By mandating training and establishing clear reporting mechanisms, the bill fosters a culture of accountability and care, where the safety and dignity of women and vulnerable individuals are prioritized.

In sum, SB0007 is not only a necessary measure to combat human trafficking but a critical tool to prevent exploitation, protect survivors, and create safer communities for all.

My name is David Pendleton, I am the Director of the Maryland Safety and Legislative Board of the Transportation Division of SMART. We represent transportation-sector employees who work for MARC and Amtrak in commuter and long-distance service. I am urging a favorable report on **SB7**, the "see someone - save someone act."

SB7 would require the Maryland Department of Transportation to develop and implement a training program for our members employed in the transportation-sector on the identification and reporting of human trafficking. According to the State Department, "there are 27.6 million people globally who are subjected to human trafficking and forced labor. It's responsible for an estimated \$150 billion annually in illicit profits. Human trafficking disproportionately impacts some of the most vulnerable and underserved members of our society. It erodes the safety and health of our communities and transportation networks, the security of our borders, the strength of our economy, and the rule of law."

A 2018 Polaris Project study of 104 survivors found that 11% of human trafficking victims are transported on long-distance Amtrak Trains, and 29% on subway/commuter rail. The study also found that "the use of buses and trains may be a preferred method of transportation for traffickers because of the low cost and limited interaction with bureaucratic systems. This allows them more anonymity in the ticket buying process and less attention from officials."

Our members who work in commuter and passenger service are the first responders to any issues experienced with operations. They are in constant contact with the traveling public and are vigilant in observing their surroundings. With the proper training they can be a great asset in the fight against human trafficking. Human trafficking is a heinous crime that has no boundaries. It is perpetrated on its victims from small towns to large cities and everywhere in between. Prevention requires action and the more employees are trained in recognizing and reporting these acts the easier it is for them to "see someone - save someone."

Governor Moore, in his 2024 State of the State speech, called for action on public safety as one of his top priorities. Nothing is more important than protecting the citizens of this state from criminals, especially our children.

SMART proudly supports this bill and emphatically urges a favorable report on SB7!

The Maryland Catholic Conference (MCC) is the public policy representative of the three (arch)dioceses serving Maryland, which together encompass over one million Marylanders. Statewide, their parishes, schools, hospitals, and numerous charities combine to form our state's second largest social service provider network, behind only our state government.

Senate Bill 7 requires the Maryland Department of Transportation to develop or identify and implement a training program for transportation sector employees on the identification and reporting of suspected human trafficking victims; requiring transportation sector employers to certify by January 1, 2026, and each year thereafter that certain employees have completed the training program; requiring new employees to receive training within 90 days of hiring; removing civil and criminal liability for reporting of suspected trafficking.

The MCC supports this bill because it emphasizes the importance of training programs to educate individuals in the transportation sector on how to identify and report human trafficking. Such training is critical for reducing the prevalence of trafficking, aiding law enforcement in their efforts to combat this crime and increasing public awareness about how to assist in the fight against trafficking.

Maryland's central location makes it a significant hub for human trafficking, serving as both a pass-through state and a destination for traffickers. Traffickers frequently utilize Maryland's extensive transportation network, including major highways like Interstate 95, to connect victims to large East Coast cities such as New York, Baltimore, Philadelphia, and Washington, D.C. Incidents of sex trafficking have been identified at Maryland truck stops, with data from the National Human Trafficking Resource Center indicating that approximately 70% of trafficking cases in the U.S. occur at truck stops.¹

Recent cases illustrate how transportation hubs facilitate trafficking. For example, in a 2024 case in Maryland, a trafficker recruited women in Hagerstown transported them across Maryland to Baltimore and exploited them in hotels near BWI Marshall Airport and local stadiums.² These examples underscore the critical need for targeted training and awareness initiatives. Pope Francis has repeatedly condemned the atrocity of human trafficking, calling it "an open wound on the body of contemporary society, a scourge upon the body of Christ."³ This bill is a significant step forward in addressing the exploitation of vulnerable individuals by equipping key sectors with the tools to recognize and prevent trafficking. It represents a meaningful contribution to the fight against child exploitation and human trafficking in Maryland.

For these reasons, the Maryland Catholic Conference asks for a favorable report on SB 7.

The Maryland Network Against Domestic Violence (MNADV) is the state domestic violence coalition that brings together victim service providers, allied professionals, and concerned individuals for the common purpose of reducing intimate partner and family violence and its harmful effects on our citizens. **MNADV** urges the **COMMITTEE** to favorably Report on SB7.

Senate Bill 7 requires the Maryland Department of Transportation (MDOT), in consultation with stakeholders, to develop or identify and implement a training program that includes a curriculum on the identification and reporting of suspected human trafficking. MDOT would be required to establish a human trafficking reporting process, to provide training to its employees within certain time periods and certify such training has occurred. It must also establish a human trafficking prevention policy as well as offer public service information as it is able.

Maryland's location on the I-95 corridor makes it a part of the broad human trafficking that occurs on the eastern seaboard. A program that increases awareness of and trains about prevention of human trafficking is important. Employees of MDOT should have the tools to recognize suspected human trafficking and have a policy for what to do if they suspect it. Other agencies in Maryland are required to do this and it makes sense for MDOT to as well.

For the above stated reasons, the Maryland Network Against Domestic Violence urges a favorable report on SB7.

The Maryland Coalition Against Sexual Assault (MCASA) is a non-profit membership organization that includes the State's seventeen rape crisis centers, law enforcement, mental health and health care providers, attorneys, educators, survivors of sexual violence and other concerned individuals. MCASA includes the Sexual Assault Legal Institute (SALI) which provides direct legal services to survivors, including sex trafficking survivors. MCASA represents the unified voice and combined energy of all of its members working to eliminate sexual violence. We urge the Judicial Proceedings Committee to report favorably on Senate Bill 7.

Senate Bill 7 – Department of Transportation See Someone, Save Someone - Human Trafficking Prevention

Senate Bill 7 requires the Department of Transportation to develop and implement a training program for transportation—sector employees on the identification and reporting of suspected human trafficking victims. Truck stops can provide runaways and others at risk of trafficking with convenient stops, and also provide a place slightly secluded from public view. Truck stops can also provide opportunities to pick up, drop off, or stop for paid sex, including with children and adults. These victims even have a name, and are referred to as "Lot Lizards" in the trucking community. Though most of the trucking industry is not involved in the sex trade, there unfortunately are consumers that fuel the trafficking. It has been reported that buyers use indicators such as stickers, flashing headlights, and code words such as "commercial" to indicate their interest. Massage parlors located at truck stops have also been knowns to be covers for sex trafficking businesses. This bill responds to these practices and will help educate those working in the transit business to identify and prevent human trafficking.

Senate Bill 7 is a straight-forward piece of legislation designed to combat child exploitation and human trafficking in our communities and to equip employees working with the Maryland Department of Transportation with the information necessary to recognize the signs of these crimes.

This bill would require the Maryland Department of Transportation to put in place both a human trafficking recognition education training program curriculum (offering guidance to employees and contractors of Maryland transit agencies, taxicab drivers, and transportation network operators on ways to recognize and respond to the signs associated with human trafficking) and a reporting procedure to when such crimes are recognized. Additionally, the bill would require (when practicable) audible public service announcements throughout Maryland transit stations, airports, port facilities, and highway rest stops.

As someone who spent the majority of his professional career in law enforcement, and as someone who personally worked to stop these types of crimes as Prince George's County Sheriff, I am confident that this legislation will provide a means to protect some of those victimized by this hidden and heinous crime in our State.

For the reasons listed above, I ask for a favorable report of Senate Bill 7.

Chair Smith, Vice Chair Waldstreicher, and Members of the Committee, please be advised that the Baltimore City Administration (BCA) **supports** Senate Bill (SB) 7.

SB 7 requires the Maryland Department of Transportation to train certain transportation sector employees on the identification and reporting of suspected human trafficking victims. Training is vital because human trafficking often occurs in public spaces where transportation employees interact with potential victims. This training can help to identify and stop human trafficking and child exploitation, thus saving and changing lives. This bill also includes liability protections, which will encourage proactive reporting, fostering a culture of vigilance and support for victims.

The City of Baltimore has seen higher rates of victim identification through increased trainings for public service employees and the posting of signage displaying the National Human Trafficking Hotline in locations such as hotel rooms and rest stops. Victims of human trafficking and child exploitation, in Baltimore City and beyond, are often forced to travel to and from locations via buses. Public transit offers traffickers low-cost travel options as well as the ability to go undetected by enforcement officers. Transportation sector employees are uniquely positioned to recognize signs of distress or suspicious behavior that may indicate trafficking. With proper training, they can become vigilant victim advocates, providing timely assistance and intervention.

For these reasons, the BCA respectfully request a **favorable** report on SB 7.

The Federal Government FEMA has identified 5 Ways We Can Work Together to Prevent Human Trafficking ¹ The United States Department of State has focused on the problem, suggesting 20 Ways You Can Help Fight Human Trafficking ² Maryland can respond positively and be a leader in combatting the problem via education to persons who are in positions to recognize and prevent it.

The bill will require the Maryland Department of Transportation to develop or identify and implement a certain training program for transportation sector employees on the identification and reporting of suspected human trafficking victims. It mandates recertification of trained individuals, requiring transportation sector employers to certify by January 1, 2026, and each year thereafter that certain employees have completed the training program. It ensures and requires that all new employees are mandated to receive training within 90 days of hiring. The bill also offers legal protections to persons that, on recognition and reporting of potential trafficking offenses those reporters will not face civil and criminal liability for reporting of suspected trafficking.

This bill will further the efforts Maryland has been undertaking in this area as outlined and reported in the Governor's Office of Crime Prevention and Policy, Statewide Human Trafficking Response Director, 2024 Annual Report. ³

I respectfully urge this committee to return a favorable report on SB0007.

TESTIMONY IN SUPPORT OF BILL SB 7

Department of Transportation - Human Trafficking Awareness, Training, and Response (See Someone, Save Someone Act)


Social Work Advocates for Social Change strongly supports SB 7, which requires the Maryland Department of Transportation (MDOT) to implement a training program for transportation sector employees to identify and report suspected human trafficking victims. This vital legislation is a powerful step toward addressing the pervasive crime of human trafficking, also referred to as modern-day slavery.ⁱ

Human trafficking is pervasive in Maryland and across the country. In 2023, the National Human Trafficking Hotline (NHTH) received 30,162 reports of suspected human trafficking, leading to 9,619 confirmed cases impacting 16,999 victims; in Maryland alone, 501 reports were made, resulting in 152 cases. These numbers only represent a fraction of the true scale of trafficking in our state, as many victims remain reluctant to come forward, unaware of available resources, or trapped by the secretive nature of trafficking operations.

Human trafficking preys upon society's most vulnerable, including children in the foster care system.ⁱⁱⁱ Human traffickers target children, and up to 70% of trafficked minors in the U.S. come from child social services or foster care.^{iv} Between 2014 and 2019, Maryland's local social services departments reported over 670 child sex trafficking cases — 93% of which involved female victims, 87% involved youth aged 14-17, and more than half were people of color.^v

Maryland's extensive transportation infrastructure — encompassing thousands of bus stops, 33 light rail stations, 14 metro stations, 10+ rest stops, 5 Amtrak stations, Baltimore/Washington International Thurgood Marshall Airport, and the Helen Delich Bentley Port of Baltimore — makes it a key location for human trafficking activities. Vi SB 7 leverages this reality to safeguard vulnerable individuals by engaging the transportation sector as a critical ally in the fight against trafficking.

SB 7 will help thwart human trafficking by training transportation sector employees to identify potential victims and connect them with vital resources, without exposing them to law enforcement—an essential consideration for undocumented individuals. By tapping into the Regional Navigator program, this bill offers a proactive solution for combatting human trafficking.





This bill builds on efforts in California and New York and complements federal law, such as the Trafficking Victims Protection Reauthorization Act (TVPRA), which mandates airline carriers to train employees on identifying and responding to human trafficking.

With SB 7, Maryland has an important opportunity to protect its most marginalized residents and take a decisive stand against human trafficking.

Social Work Advocates for Social Change urges a favorable report on SB 7.

ATU Local 1300 represents over 3,000 transit workers at the Maryland Transit Administration (MTA). Our members keep Maryland moving every day.

We strongly support efforts to combat human trafficking. The forward facing role transit professionals have means that we see and interact with the riding public every day. Our only note on SB 7 is that it does not clarify that the mandatory training would occur while on paid time and on the clock. This is not an issue for MTA workers who have the protections of a collective bargaining agreement, but multiple MDOT transit contractors do not have unions and therefore have no guarantee that training required for their jobs are compensated.

To ensure that these trainings are given the proper attention and supervision that they deserve, we urge you to amend the bill to clarify that the required training should be conducted during paid work time, regardless of whether they are a contractor or state employee.
