As Chiefs of Police across Prince George's County, we are here today to express our collective and unwavering support for legislation authorizing automated enforcement of distracted driving.

Every day, we see firsthand the consequences of distracted driving: avoidable crashes, severe injuries, and lost lives. Distracted driving is not just a problem—it is an epidemic. A countywide pilot program revealed a staggering **1,250 violations per day** across just four locations, with an alarming **30% of drivers** failing to give the road their full attention. These statistics are not just numbers; they represent real dangers to our communities, our families, and our officers.

Traditional enforcement for distraction is close to impossible — methods require significant time and manpower, often forcing officers to choose between enforcing traffic laws and responding to emergencies. Automated enforcement provides a solution that allows us to deter dangerous behavior while keeping officers focused on critical public safety duties.

When other types of automated enforcement were first introduced in our communities, many residents were skeptical, fearing privacy concerns and revenue motives. However, a oncedangerous intersection plagued by crashes saw immediate improvements—fewer drivers running stop signs, fewer speeding vehicles, and, most importantly, fewer crashes. Over time, former critics became strong advocates, seeing safer streets, protected pedestrians, and more secure businesses. Today, parents, seniors, and local shop owners support these measures, knowing they make our communities safer.

Automated enforcement is a proven tool for improving road safety, and we need a solution to end this key cause of pedestrian fatalities. We urge you to support this legislation and take a stand for safer roads, for fewer tragedies, and for a Prince George's County where every resident—whether driver, pedestrian, or cyclist—feels protected.

Greetings Chairman Smith and the members of the Maryland Senate Judicial Proceedings Committee.

My name is Daniel Franklin, and I am the Chief of Police for the Morningside Police Department in Prince George's County, Maryland. After careful review of SB 0613 sponsored by Senators Jackson and Waldstreicher, I am submitting this written testimony **SUPPORTING** the passage of the bill.

Distracted driving is any activity that diverts attention from driving, including talking or texting on your phone, eating and drinking, talking to people in your vehicle, fiddling with the stereo, entertainment or navigation system — anything that takes your attention away from the task of safe driving as per the National Highway Traffic Safety Association.

In 2022, NHTSA reported that 3,308 people were killed due to distracted driving in the United States. Maryland Department of Transportation Motor Vehicle Administration (MDOT MVA) reports that approximately 27,000 people are killed or injured in distracted driving accidents every year. In response to this issue, the Maryland General Assembly passed Senate Bill 321 and House Bill 924 making use of handheld cellular phones while driving an illegal act. Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for 5 seconds. At 55 mph, that's like driving the length of an entire football field with your eyes closed!

The use of technology to combat traffic offenses is an ever-evolving solution employed by thousands of governmental units and law enforcement agencies across the United States. Automated enforcement has become even more important due to what some Police administrators and managers are calling a manpower crisis

because of declining interest in the law enforcement field. Automated enforcement cannot replace a Police Officer, but that technology can supplement the efforts of the Police by helping reduce distracted driving by conducting enforcement actions. The bottom line in conducting any distracted driving enforcement is to promote greater roadway safety for all drivers, passengers, and pedestrians. By seeking legislation to allow automated distracted driving enforcement, the counties of Prince George's and Montgomery will show their commitment to the overall highway safety mission. By passing this bill, the Maryland General Assembly will show that they too are committed to that same mission and are prepared to take the necessary steps to prevent injuries and deaths due to distracted driving.

For these reasons, I ask that the committee give a favorable report on SB 0613 and accept my written testimony **SUPPORTING** SB 0613.

The detection can be used to support driver monitoring systems similar to speed, red-light and other types of monitoring systems. Evidence captured would include video evidence of the

vehicle in motion, front (or back) license plate photo, and a privacy-focused image of the behavior in action.

These systems can be entirely cost-neutral to municipalities as the cost of this technology has been reduced significantly and can be covered by citation revenue. Any additional citation revenue collected can be used to fund pedestrian safety initiatives (education, check-points, engineering and more).

Obvio Background

Obvio is a Silicon Valley-based technology company, dedicated to improving road safety for our communities, schools, and neighborhoods. As parents ourselves, we started feeling a sense of anxiety on our way to school pick-up & drop-off in the mornings and afternoons: more drivers are speeding, skipping stop signs, using cell phones while driving, than ever before. The Maryland Coalition for Roadway Safety (SafeRoadsMD) urges your support for SB 0613 - "Montgomery County and Prince George's County – Distracted Driving 3 Monitoring System Pilot Program." We thank Sen. Waldstreicher and Sen. Jackson for crafting and co-sponsoring the bill.

The Crisis: Distracted Driving Kills More Marylanders Than Any Other Factor

Despite existing laws prohibiting handheld phone use while driving, enforcement remains a significant challenge, leaving our roads unsafe for all. The **Maryland Department of Transportation (2023)** confirms that distracted driving is now the leading cause of crashes and fatalities in our state, annually accounting for:

- 203 deaths—34% of all traffic fatalities and
- **50,000 crashes**—a staggering 46% of all reported accidents.

On a national level, the **National Highway Traffic Safety Administration (NHTSA)** recently reported that distracted driving fatalities run far higher than previously estimated, likely exceeding **10,000 deaths per year**—nearly **29% of all traffic fatalities**.

Support

I am writing to express my support for Senate Bill 613, *Montgomery County and Prince George's County - Distracted Driving Monitoring System Pilot Program.* The legislation would allow Montgomery and Prince George's Counties to pilot an automated enforcement system to detect distracted driving. The bill specifies prohibited use of a handheld cell phone while operating a vehicle as distracted driving but maintains existing exclusions for the use of a cellphone while driving to contact global positioning systems (GPS) or text messaging to a 9-1-1 system. Under the bill, a person liable for a violation would be subject to a civil fine not exceeding \$40 to be paid directly or appealed to the District Court.

Distracted driving is a risk to public safety on our roadways. It diverts a driver's attention, and in a matter of seconds, can reduce a driver's response time to traffic conditions. The National Highway Traffic Safety Administration reported that more than 32,000 people died in crashes involving distracted driving between 2013 and 2022. That includes any activity that takes a driver's attention away from the road, and it is an alarming statistic for preventable deaths. In Montgomery County's efforts to advance our Vision Zero goals, last year, we ran a small proof of concept study of automated enforcement technology to detect distracted driving involving the use of a cell phone. After three days of testing the equipment at three locations in the County. Nearly 800 violations were recorded over the three-day period.

Authorizing a limited pilot of this automated enforcement technology in Montgomery and Prince George's Counties would allow for a more robust study of the technology and provide a greater opportunity to identify potential issues that could be improved upon before considering a wider deployment.

To that end, I urge that the Committee adopt a favorable report on Senate Bill 613.



Dear Chair Smith and Vice Chair Waldstreicher:

There is an epidemic of distracted driving on our roadways. For this reason I strongly support the passage of SB0613 - "Montgomery County and Prince George's County - Distracted Driving Monitoring System Pilot Program." I respectfully request that the Senate Judicial Proceedings Committee submit a favorable response to enact this bill.

Having lost my son Brett as he was crossing the street to meet some friends for dinner, I have been advocating for safer streets for the past five years. I believe my experiences give me a personal perspective on roadway safety.



Many people are choosing to ignore the fact that when they operate their vehicle without full attention, they can cause lasting catastrophic impacts to themselves and others. They are driving irresponsibly when they choose to use their wireless communication devices when they are behind the wheel.

I am sure that all of us have experiences with distracted drivers on their cell phones. In one particularly memorable event, I was driving on Route 32 when a driver with a cell phone in their hand tried to merge onto the roadway; they did not look to see if it was safe to do so. I very narrowly avoided a crash that day, and the sight of that person looking down at their device is one I will never forget.

In 2024 there were 556 fatalities on our Maryland roadways, 140 of those fatalities occurred in Montgomery and Prince George's Counties. I live near MD 210, and it is my main street. Every day, I share this highway with 80,000 vehicles, some of which are driven by people who take reckless and dangerous risks including using their cellphone while driving. My goal, like so many others who travel this dangerous road, is simple: I just want to get home safely.

I strongly support the use of an automated system to enforce distracted driving laws on MD 210 because:

Distracted driving leads to **longer reaction times** which contributes to a high crash risk and a higher risk of a more serious crash.

Enforcing distracting driving laws is resource-intensive and not always effective.

Automated enforcement of distracted driving has been proven effective:

The Australian New South Wales (NSW) Government implemented mobile phone detection cameras in 2019, and a **six-month trial** identified over **100,000 violations** from **8.5 million vehicles**.

The violation rate **dropped by two-thirds** since the program's introduction.

I am convinced that this pilot program will save lives on MD 210.

To Chair Smith and members of the Judicial Proceedings Committee,

I support SB0613, which establishes a pilot program for a driver monitoring system in Montgomery and Prince George's Counties.

As a person who uses active transportation regularly, I encounter weekly, if not multiple incidents per week, where drivers are looking at their phones, texting, eating, or otherwise doing something distracting while they are supposed to be driving. It's obvious, they are looking somewhere else and failing to identify me as a pedestrian trying to cross the road at a crosswalk during school hours, adjacent to school property. I've been hit before while almost completing my crossing at this intersection only to have someone speed through without seeing me. Additionally, it has become unsafe to bicycle on the shoulders of the road due to people looking down at their large in-vehicle dashboards and swerving into the shoulder and generally not moving an inch left to pass me.

Everyone encounters distracted drivers at intersections, the light turns red, many people try to text or read information from their phone, then the light turns green and the vehicle in front doesn't move. This seems harmless, but it has become the norm and results only in aggressive driving from those behind.
