AMENDMENTS TO SENATE BILL 626
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Senator Folden**” and substitute “**Frederick County Senators**”; strike beginning with “equal” in line 3 down through “plan” in line 5 and substitute “a certain amount for a certain calendar year; altering the annual salary of the Sheriff of Frederick County to be a certain percentage of the salary of the State’s Attorney for Frederick County for certain subsequent calendar years”.

AMENDMENT NO. 2

On page 1, in line 22, strike “**SALARY FOR THE**”; in the same line, strike the opening bracket; and in line 23, before “\$125,000” insert an opening bracket.

On pages 1 and 2, strike beginning with “**IS**” in line 23 on page 1 down through “**OFFICE**” in line 4 on page 2 and substitute “:

(I) \$187,313 FOR CALENDAR YEAR 2025; AND

(II) 82.5% OF THE STATE’S ATTORNEY FOR FREDERICK COUNTY’S ANNUAL SALARY INCLUDING ANY INCREMENTS AND SALARY ADJUSTMENTS AUTHORIZED UNDER § 15-411(B)(2) OF THE CRIMINAL PROCEDURE ARTICLE FOR CALENDAR YEAR 2026 AND EACH SUBSEQUENT CALENDAR YEAR”.

On page 2, strike beginning with “**UNDER**” in line 5 down through “**PLAN**” in line 6 and substitute “**TO THE STATE’S ATTORNEY FOR FREDERICK COUNTY**”.
