(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, after the second "–" insert "**Repeal of Maximum**"; and in line 3, strike "increasing" and substitute "<u>repealing</u>".

AMENDMENT NO. 2

On page 2, in line 1, strike "no fine or penalty shall exceed [\$1000.00] **\$10,000.00** and"; and in line 4, after "2025." insert "It shall remain effective for a period of 5 years and, at the end of September 30, 2030, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.".
