Dear Chair Smith, Vice Chair Waldstreicher, and Members of the Judicial Proceedings Committee:

This letter is submitted on behalf of the Maryland Legislative Action Committee (“MD-LAC”) of the Community Associations Institute (“CAI”). CAI represents individuals and professionals who reside in or work with community associations (condominiums, homeowners’ associations, and cooperatives) throughout the State of Maryland.

We write on behalf of the Maryland residents statewide who reside in condominiums to oppose the above-referenced legislation, which is scheduled for hearing before your Committee on Thursday, February 6, 2025, at 1:00 p.m.

SB 0464 as currently written sets a cap of 5% on increases to annual condominium assessments that can be adopted by the Board of Directors. Such cap places an artificial ceiling on expenses that condominiums across the state must pay. For example, during the past few years, condominiums have experienced insurance, utility, supply, and vendor costs that well exceed the proposed 5% annual cap. With such a cap, these condominiums would not be able to afford any of these necessary expenditures. CAI has studied this issue and more than thirty years ago adopted a Public Policy opposing assessment caps. Specifically, CAI has determined that

Assessment increases should be based upon a board of directors' prudent estimate of the funds necessary to meet anticipated expenses for the benefit of its association. The board, not a third-party public or governmental agency, has the fiduciary obligation and is in the most informed position to manage the finances of its own private community.
