House Bill 1429 - Youth Services Bureaus - Criminal History Records Checks - Employees, Volunteers, and Interns

### Support

The Carroll County Youth Service Bureau (CCYSB) supports HB 1429 which will authorize Youth Service Bureaus to request a criminal history records check from the Criminal Justice Information System Central Repository for employees, volunteers, and interns.

The Carroll County Youth Service Bureau (CCYSB) is part of the statewide structure of Maryland Youth Service Bureaus for over 50 years. CCYSB is a multifaceted outpatient mental health treatment agency licensed by the Maryland Department of Health and Mental Hygiene, certified by the Council for the Accreditation of Rehabilitative Facilities (CARF), and certified by the Department of Juvenile Services. Treatment and prevention services are largely designed to support children, adolescents, and families, with adult services available as well. Treatment options include psychotherapy and psychiatric evaluations, and home-based services through the Family Preservation, Assertive Community Treatment, and Mobile treatment programs, and many programs serving youth of all ages. Additionally, we offer five (5) evidence-based treatment programs.

HB 1429 corrects an unintended consequence of a recent federal policy that limits access to federal background checks. Though MAYSB supports the reasons for the policy change, the current rules make it impossible for Youth Service Bureaus to conduct a full screening of new employees, interns, and volunteers, especially those who have lived in or traveled to another state.

While we are not currently experiencing the limitations of procuring federal background checks, I can assure you that our ability to comply with safety regulations from the State of Maryland and our accrediting agency (Council for the Accreditation of Rehabilitative Facilities- CARF) would be severely limited without the ability to have federal background checks for staff and interns.

Passage of HB 1429 would assist Youth Service Bureaus with creating the safest environment possible for the children and families we serve.

HB 1429 corrects an unintended consequence of a recent federal policy that limits access to federal background checks. Because of this change, Youth Service Bureaus (YSBs) are not able to properly screen potential employees, interns, and volunteers.

As The Baltimore City Youth Services Bureau, we have proudly served the community since 2022. Our agency provides vital services such as barrier removal, case management, mentoring, entrepreneurship initiatives, and workforce development programs for minors. Each year, we connect with hundreds of local youth, empowering them to overcome obstacles and achieve their goals.

To ensure the safety and well-being of our scholars, it is imperative that we obtain approval for comprehensive background checks—including federal checks. Currently, we only have access to Maryland state background checks, which limits our ability to fully vet the adults who work closely with our youth. Without access to federal checks, we cannot adequately assess whether an individual has a criminal record outside of Maryland, posing a significant risk to our service delivery and the safety of those we serve.

We believe that ensuring the highest standards of safety is essential in fostering a supportive and secure environment for our youth. Therefore, we are seeking approval to facilitate these critical background checks, allowing us to continue our mission effectively and responsibly. HB 1429 would strengthen the ability to provide a safe environment for our youth.

Lighthouse, Inc., Youth and Family Services supports HB 1429, authorizing youth services bureaus to request a criminal history records check from the Criminal Justice Information System Central Repository for employees, volunteers, and interns.

Lighthouse is a community-based member of the Maryland Association of Youth Service Bureaus (MAYSB), providing counseling, psycho-educational groups, and other mental health services to at-risk children, teens, and their parents, for over 50 years. The existing rules allow us to do background checks for any offenses committed within the state of Maryland, but make it impossible for Youth Service Bureaus to conduct a full and complete screening of the adults who will be working with our youth, especially those who have lived in or traveled to another state. Passage of HB 1429 would assist Lighthouse and other Youth Service Bureaus with ensuring the safest environment possible for the youth and families we serve.

To The Members of the Committee,

The District Heights Family and Youth Services Bureau **supports HB 1429** which will authorize Youth Service Bureaus to request a criminal history records check from the Criminal Justice Information System Central Repository for employees, volunteers, and interns.

Historically, Youth Service Bureaus (YSBs) have run federal background checks as a crucial part of our screening process. However, two years ago, some YSBs lost access to these checks due to a new FBI rule aimed at improving job opportunities for individuals with criminal histories. While this policy change has brought benefits in many areas, it has inadvertently impacted our ability to access federal background checks.

As a result, YSBs are now limited to conducting only State of Maryland fingerprinting and background checks. While not all YSBs have encountered this issue yet, it has become a widespread challenge. According to the Criminal Justice Information System (CJIS), we can only gain access to federal checks through specific statutory authorization.

These restrictions have made it difficult, if not impossible, to complete a comprehensive screening process, particularly for individuals who have lived in or traveled to other states. Without access to these broader checks, our ability to ensure the safety and well-being of those we serve is significantly limited.

We respectfully request your support of this bill.
