# Support Testimony for HB1423 – Commission to Review and Assess Racial Disparities in the State Criminal Justice System - Establishment

Chairperson and Esteemed Members of the Committee,

My name is Maureen Wambui, and I am a proud Immigrant, Parent, Community advocate and resident of Legislative District 8 in Maryland. I appreciate the opportunity to testify to and express my **strong support** for HB1423, which would establish a commission to review and assess racial disparities within our state's criminal justice system.

For too long, communities of color, particularly Black, Hispanic, and immigrant populations, have faced disproportionate policing, harsher sentencing, and systemic barriers to justice. HB1423 is an important step toward acknowledging these disparities, understanding their root causes, and developing policies that ensure fair treatment for all Maryland residents, regardless of race or background.

#### Why HB1423 is Necessary

#### 1. Data-Driven Solutions to Racial Disparities

#### 3. Impact on Immigrant & Minority Communities

- Immigrants and minorities often lack legal representation, face language barriers, and are disproportionately targeted by certain enforcement policies.
- Many immigrants, particularly Black and Latino individuals, are at higher risk
  of deportation due to minor infractions that might not affect U.S. citizens in
  the same way.
- Understanding these disparities will help Maryland create policies that promote fairness, prevent racial profiling, and protect vulnerable communities.

#### 4. Aligning Maryland with National Justice Reform Efforts

- Across the country, states are taking proactive steps to address systemic racism in the justice system.
- By passing HB1423, Maryland can position itself as a leader in equitable justice reforms, ensuring that our policies reflect fairness, rehabilitation, and community safety.
