The Southern Maryland (SoMD) Chapter of the Democratic Socialist of America (DSA) strongly supports universal housing justice – the principle that all people deserve a secure home, a place that will not be arbitrarily taken from them or deliberately destroyed or rendered uninhabitable. People deserve to live without fear of eviction or displacement by either a state or landlord. This is true in Maryland and around the world.

SoMD DSA is a proud advocate of housing as a human right. When residents of Lord Calvert Mobile Homes faced displacement from redevelopment and gentrification, we helped them save their homes and form a tenant association. We have also fought for social housing in Saint Mary's County, and plan to continue that fight until tenants have democratic control over their housing.

Our belief that a home is a human right extends far beyond our borders and to the international working class - especially those being colonized and displaced. We ask the Maryland General Assembly to ask a basic question for every bill: Does it promote human dignity or does it undermine it?

Right now, the State of Maryland incentivizes housing <u>injustice</u> by allowing Marylanders to take a tax deduction for contributions to "charities" that promote Israeli settlement of Palestinian land in the occupied territories such as the West Bank and East Jerusalem, which forcibly displaces Palestinians not only from their physical homes, but from their ancestral homeland.

These settlements are deemed illegal under United Nations Security Council Resolutions 446 (1979), 452 (1979), 465 (1980), and 2334 (2016). Most recently, in July 2024, the International Court of Justice found that Israel's settlement regime was an illegal military occupation, segregation and apartheid.

The human consequences have been devastating to Palestinians, who have seen their homes and supporting infrastructure destroyed, along with livestock and crops. Israeli settlers and the Israel Defense Force have killed hundreds of Palestinians in a brutal campaign to force them from the homes where many families have lived for generations. Even in the past few days, Israeli tanks have entered the West Bank city of Jenin, forcing 40,000 Palestinians to flee their homes, followed by a statement from the Israeli Minister of Defense that the intent is "prevent the return of residents." The nature and scale of this injustice is in no way defensive and occurring on our dime.

If made law, HB 1394 would stop this injustice. We urge the Committee to pass HB 1394.

Testimony in Support of HB 1394 - Civil Actions - Nonprofit Organizations - Unauthorized Support of Israeli Settlement Activity (Not On Our Dime Act)

I have been fortunate to have had the opportunity to hear Rabbi Arik Ascherman speak about his experience trying to protect Palestinians in the West Bank against the harassment, theft, and violence that is routinely perpetrated by Israeli settlers. These acts are intended to discourage Palestinians from herding and olive harvesting and to encourage them to abandon their land so that Israelis can expropriate it. The Israeli Defense Force permits these illegal acts.

Rabbi Ascherman is the founder of the organization, "Torat Tzedek-Torah of Justice," and he has a long history of human rights work. <u>Here</u> is an excerpt of his story of defending a Palestinian shepherd last August:

Then settlers on motorcycles tore into his flock, scattering them and driving them towards a [Jewish] settlement, where they would disappear forever. We almost never manage to recover stolen flocks. My fellow human rights defenders chased after them and managed to begin to bring them back. The motorcycles came back and scattered them again.

Rabbi Ascherman's story gives us a window into the kinds of illegal actions that Maryland charities should not be allowed to support – the kinds of actions that motivate the introduction of HB 1394.

When the ceasefire in Gaza began on January 19, 2025, Israel dramatically escalated its illegal actions in the West Bank. According to <a href="National Public Radio">National Public Radio</a>, more than 40,000 people have been forced from their homes. "In Jenin refugee camp, bulldozed roads were photographed with new street signs reportedly now written in Hebrew." (<a href="United Nations">United Nations</a>.) When we hear that Israel wants all Palestinians to be expelled from Gaza, we should understand that this applies more broadly to the West Bank.

All these actions described in the definitions section on pages 2 and 3 of HB 1394 are illegal under international law, and we should not be complicit in supporting this type of ethnic cleansing. Please issue a favorable report on HB 1394, and take one small step for justice.

My name is Justin Li and I am a District 17 constituent living in Rockville. I am writing to urge the House Judiciary Committee to adopt House Bill 1394, Not On Our Dime Act. This legislation is a vital step toward ensuring that Maryland's nonprofit organizations cannot misuse their tax-exempt status to fund illegal Israeli settlement activity in occupied Palestinian territories. It aligns our state's values with international law, human rights, and the conscience of our communities.

Throughout last year, as a senior at University of Maryland, I mobilized with other students calling for investment transparency and accountability of the school in response to the war in Gaza. I witnessed my Palestinian classmates collapse in tears recalling receiving calls that their relatives were killed in between classes. Palestinian stories and images like this have haunted me, as I'm sure to all others who have the basic human empathy. I learned from the same students how the war carries the same colonial logic of the decades of violent settlements, and we ought to stop all the ways Maryland is still materially funneling it.

Recent reports from the United Nations confirm that Israel's settlement operations have reached a devastating tipping point. In January 2025, a military offensive displacing 40,000 Palestinians in the West Bank destroyed critical infrastructure—water systems, homes, even animal shelters—and rendered entire refugee camps "uninhabitable." These actions, part of Operation Iron Wall, echo the brutality of past military campaigns, violating the Geneva Conventions through forced transfer, collective punishment, and the systematic annexation of land. This is not an isolated incident. For decades, illegal settlements have displaced Palestinians and carved their homeland into fragmented "bantustans". Over 700,000 settlers now occupy stolen land, enabled by violence, discriminatory laws, and the complicity of external actors.

Tax-exempt organizations in the U.S. can play a direct role in this crisis. US synagogues have hosted real estate fairs for groups like My Home in Israel, which market West Bank settlements, promoting properties built on land seized through ethnic cleansing. Nonprofits shouldn't be able to exploit charitable registries to subsidize war crimes, all while enjoying public trust and tax benefits, and this bill provides a mechanism for the state to act decisively on this principle.

When I marched with my classmates to divest from genocide-profitteers last year, my Jewish friends—who once found solace in cultural spaces—were forced to host private Shabbat dinners due to their opposition to the war. Some of their communal institutions have became political

battlegrounds, even diverting money and resources to rally people to organize against the student movement for Palestine.

This is the hypocrisy HB 1394 confronts: nonprofits masquerading as charitable entities while facilitating the violation of international human rights. They claim to serve "cultural" or "religious" missions, but one way or another, their dollars fund bulldozers that erase Palestinian villages, sniper towers that surveil families, and laws that bar UNRWA from delivering food to starving children.

Please pass HB 1394; declare that not one more dollar from our state will fuel more Israeli settlements. The Palestinian child drinking sewage-contaminated water in Jenin, the Jewish student ostracized by politicized communal spaces, and the Maryland taxpayers unwittingly funding this horror demand nothing less.

### **TESTIMONY IN SUPPORT OF HB 1394**

Civil Actions - Nonprofit Organizations - Unauthorized Support of Israeli Settlement Activity (Not On Our Dime Act)

As a lifelong Maryland resident and advocate for human rights, I strongly support HB 1394, which will prohibit non-profit organizations in Maryland from advancing illegal settlements in the West Bank, including East Jerusalem, and create a legal pathway to compensation for affected parties. The bill defines prohibited activities as those banned under the Geneva Conventions, including the unlawful transfer of civilians into occupied territory, acts of settler violence, crimes against property, blocking access to and annexing Palestinian lands, forced displacement, and the destruction of infrastructure. The bill also requires the Maryland Secretary of State to remove non-profits found in violation from the Registry of Charitable Solicitation.

For Palestinians, Israeli settlement activity in the West Bank brings extreme violence, dispossession, and forced displacement. In Hebron, for example, horrific acts of settler violence and the occupying Israeli army have pushed thousands of Palestinian residents from the City Center, and hundreds of Palestinian businesses and residences have been shuttered.<sup>1</sup> Olive trees, central to the Palestinian economy, are systematically removed by the occupying army and settlers in an effort to destroy Palestinian livelihoods.<sup>2</sup> These land grabs have only intensified since 2023.<sup>3</sup> As of this year, three West Bank refugee camps have been violently cleared of their residents.<sup>4</sup>

In 2015, I visited the West Bank and saw firsthand the horrors of the Israeli Occupation, including many of the prohibited activities outlined in this bill. I met families whose homes had been broken into at all hours of the night, vandalized by the Israeli army. I saw settlers, many of whom are U.S. citizens, disrupt the Muslim call to prayer at Ibrahimi Mosque, chanting "Death to Arabs." Soon after returning to the U.S.,

a Palestinian mother and activist who I met in the town of Nabi Saleh, while nonviolently protesting the annexation of her land, was shot with live ammunition by Israeli soldiers.<sup>5</sup> I wondered-and continue to wonder-how these actions, illegal under international law,<sup>6</sup> could go unchecked.

U.S. non-profit organizations, including in Maryland, are crucial to the violent architecture of Israeli settlement enterprise.<sup>7</sup> For example, organizations like the Jewish National Fund, superficially known as a tree-planting organization, use subsidiaries to illegally acquire land in the West Bank for Israeli settlements.<sup>8</sup> In 2015, a Haaretz investigation revealed over \$220 million in tax-exempt funds used to advance settlement activity.<sup>9</sup> The Guardian more recently documented how crowdfunding campaigns are used for this purpose.<sup>10</sup> Yet, there is little public acknowledgement of this fact, and no legal consequences for these organizations, who continually violate international-and likely domestic U.S. discrimination law-through their actions.

Non-profit organizations in Maryland should not be allowed to take advantage of their tax status in order to promote Israeli settlement activities, which violate international law and human rights. As a Maryland taxpayer, I am ashamed that our nonprofit sector may be used to funnel financial and logistical support to a foreign government and its civilian actors, who repeatedly violate the Geneva Conventions and enact extreme violence with impunity. HB 1394 creates a necessary legal mechanism by which nonprofits can be held accountable for these actions.

### I urge the committee to report favorably HB 1394 to the full House.

My name is Mary Ella Jourdak. I am writing to express my strong support to HB1394, the Unauthorized Support of Israeli Settlement Activity (Not On Our Dime Act). This is a small step towards addressing Maryland's role in the ongoing displacement and genocide of the Palestinian people.

While I appreciate that the genocide and displacement of Palestinians may not be at the top of all Maryland lawmaker's minds, it is important to understand that both our tax dollars, and the donations of Marylanders to non-profit organizations, can be directly linked to Israel and their occupation and theft of Palestinian land.

In 2024, Israel illegally claimed 23.7 sq km of Palestinian land. That is the equivalent of 3,330 football fields, or 322 White House grounds. Please refer to graphic 1 and graphic 2 at the end of this letter.

These illegal claims on land create illegal settlements, which the United Nations security council has called "a flagrant violation under international law". Furthermore, this landgrab does not happen in a vacuum, where land is peaceably stolen. In 2025 alone, 81 residents of the Westbank, including 17 children, have been killed.

In 2015, Israeli newspaper Haaretz wrote that at least 50 non-profit organizations across the US were involved in fundraising for Israeli settlements. Haaretz wrote that money went "toward providing legal aid to Jews accused or convicted of terrorism, and supporting their families" through a "legal aid society" called Honenu. "Among those who benefited from the group's support in 2013 were the family of Ami Popper, who murdered seven Palestinian laborers in 1990, and members of the Bat Ayin Underground, which attempted to detonate a bomb at a girls' school in East Jerusalem in 2002."



Today, 700,000 settlers live in about 300 settlements and outposts dotting the occupied West Bank and East Jerusalem.







Social Work Advocates for Social Change strongly supports HB 1394, which will prohibit nonprofit organizations in Maryland from engaging in or supporting activities that contribute to Israeli settlement expansion in the occupied West Bank, including East Jerusalem, and which are banned under the Geneva Conventions. If a nonprofit is found in violation, the Maryland Secretary of State is mandated to remove it from the state's Registry of Charitable Solicitation. The bill outlines prohibited actions, such as facilitating the movement of Israeli civilians into these areas, engaging in violence against protected persons, annexing Palestinian land, damaging property, or obstructing access to vital resources by the Israeli government or citizens. In the event of a violation, the Maryland Attorney General or an affected party may pursue legal action against the nonprofit, seeking damages and attorney's fees. This bill provides a crucial avenue for legal recourse to those harmed by illegal Israeli land annexation and settler violence in the West Bank.

As social workers in the state of Maryland, we are committed to upholding the core values of our vocation, including social justice and human dignity. These principles compel us to oppose actions that perpetuate inequality, displacement, and harm to vulnerable communities. Thus, we believe it is our ethical responsibility to advocate in favor of this bill.

Nonprofit organizations in Maryland mustn't support activities that violate international law, as such actions undermine global efforts to promote peace, justice, and human rights. The UN General Assembly, in a September 2024 resolution, urged states to refrain from recognizing or supporting Israel's unlawful presence in the Occupied Palestinian Territory,<sup>1</sup> echoing the International Court of Justice's (ICJ) advisory opinion that declared the Occupation illegal.<sup>2</sup> Israeli settlements in the West Bank, including East Jerusalem, violate international law, including the Fourth Geneva Convention, and contribute to the displacement of Palestinian communities, land

confiscation, and denial of basic rights.<sup>3</sup> By prohibiting Maryland-based nonprofits from enabling these activities, this bill ensures the state is not complicit in violations of international law and aligns with global calls for accountability and justice.

Passing this bill would create a meaningful avenue for individuals and communities harmed by illegal Israeli settlements to seek justice and compensation when these settlements are funded or supported by nonprofits in Maryland. Illegal settlements have caused significant harm to Palestinian families and communities, both material<sup>4</sup> and psychological.<sup>5</sup> By allowing affected individuals to bring legal action against nonprofits that fund illegal settlements, the bill empowers those who have suffered to hold accountable the organizations enabling these injustices. This not only offers a measure of redress for victims but also reinforces Maryland's commitment to upholding human rights, accountability, and the rule of law on a global scale.

Maryland nonprofits enjoy tax exemptions designed to benefit the public, not to fund or enable actions that contribute to human rights abuses or illegal occupations. By barring nonprofits from financially supporting Israeli settlement activities, this bill ensures that tax benefits are not inadvertently used to sustain practices deemed unlawful by international authorities, including the United Nations and the International Court of Justice (ICJ). This measure strengthens accountability and guarantees that tax-exempt status is granted only to organizations that uphold charitable principles.

Social Work Advocates for Social Change urges a favorable report on HB 1394.

On behalf of the Maryland office of the Council on American-Islamic Relations (CAIR), thank you for the opportunity to testify in strong support of House Bill 1394, the Not On Our Dime Act, which aims to prohibit nonprofit organizations operating in Maryland from supporting illegal Israeli settlement activity in occupied Palestinian territories in violation of international law.

The Jewish Community Relations Council of Greater Washington (JCRC) serves as the public affairs and community relations arm of the Jewish community. We represent over 100 Jewish organizations and synagogues throughout Maryland, Virginia, and the District of Columbia. The JCRC is strongly committed to cultivating a society based on mutual respect, justice and equity. We work throughout the region to advocate for our agencies that serve the most vulnerable residents on a nonsectarian basis residents and to campaign for important policy interests on behalf of the Jewish community and all Marylanders.

The JCRC strongly opposes House Bill 1394 which prohibits nonprofits from working with the Government of Israel and Israelis who support "settlement activity." The Bill demonizes and delegitimizes Israel, focusing on certain activities and alleged violence that is not unique to Israel, yet singles it out. The language of HB 1394 is dangerous and misleading, criminalizing support for the mere presence of Jews in areas where they have lived for thousands of years. The Bill also is overly broad. It gives the Maryland Secretary of State power to revoke a nonprofit's status and the Attorney General power to sue a nonprofit and its officers for damages of not less than \$1 million and with a statute of limitation of ten years.

House Bill 1394 promotes an agenda that is harmful to Israelis, Palestinians, and Marylanders, by taking action against charitable organizations which are actually delivering critical services and humanitarian aid to the region. The language of the Bill demonstrates a lack of understanding of the history and dynamics of the region. It refers to East Jerusalem as "occupied territory" although the most holy sites in Judaism including the Old City and Western Wall are in East Jerusalem. Instead of working towards a peaceful resolution to the conflict in the region, HB 1394 undermines those efforts and only causes more harm and fuels more hatred and division. For these reasons, we ask for an unfavorable report on HB 1394.

## **OPPOSE HB1394**

Dear Chair Clippinger and the Members of the Committee,

I am writing to express my strong opposition to House Bill 1394, which seeks to prohibit nonprofit organizations from supporting Israeli settlement activity. This bill is a misguided attempt to isolate Israel and undermine its legitimate efforts to protect its citizens and ensure the survival of the State of Israel.

As you are aware, Israel is a democratic nation with a right to self-defense and self-preservation. The bill's focus on Israeli settlement activity ignores the broader context of the Israeli-Palestinian conflict and the numerous security threats faced by Israel. This could lead to a chilling effect on the exercise of free speech and the ability of nonprofit organizations to engage in advocacy and education on issues related to the Israeli-Palestinian conflict.

In conclusion, I urge you to reject House Bill 1394 and instead focus on promoting a more balanced and nuanced approach to the Israeli-Palestinian conflict. By doing so, we can work towards a more just and peaceful resolution to this complex issue, rather than perpetuating a misguided and counterproductive approach that seeks to isolate and demonize Israel.

ADL (the Anti-Defamation League) is pleased to submit this testimony in strong <u>opposition</u> to *House Bill 1394, Civil Actions – Nonprofit Organizations – Unauthorized Support of Israeli Settlement Activity (Not on Our Dime Act)*.

Since 1913, the mission of ADL (the Anti-Defamation League) has been to "stop the defamation of the Jewish people and to secure justice and fair treatment to all." As a leading anti-hate organization, for decades one of the most important ways in which ADL has fought against bigotry and antisemitism has been by investigating extremist threats across the ideological spectrum, producing research to inform the public, and working with law enforcement, educators, the tech industry, and elected leaders to promote best practices to effectively address and counter these threats. Further, ADL conducts an annual Audit of Antisemitic Incidents, which is widely used by law enforcement, educational institutions, elected officials, and the community at large to not only respond to antisemitic incidents, but also to create change.

HB1394 has been rightfully questioned by many in the community, and we urge this body to oppose this dangerous bill as leaders of the Maryland General Assembly. We have grave concerns that this bill targets nonprofits doing important work here in Maryland and around the world. Its broad language could and likely would punish many Jewish and pro-Israel nonprofit organizations, calling for them to have actions taken against them by the Attorney General (AG). The AG could bring an action for injunctive relief and damages against a director, officer, partner, trustee, manager, or any other agent of the nonprofit who is found in violation. Further, it states the AG may be allowed to seek not less than one million dollars in damages. The bill goes even further in that it would allow an individual not just the Attorney General the ability to seek injunctive relief and damages against the organization and all the named parties above. Finally, it allows the AG or prevailing plaintiff to remove the nonprofit from the registry of charitable solicitation.

This bill risks eliminating a huge swath of Jewish communal nonprofits, including those that do humanitarian and life-saving work. We are extremely concerned that this bill would divide Marylanders and distract them from the important issues we face in our state every day. We are asking you to recognize this harm and speak out against this bill. Another large concern is that the bill's language seeks to inject Maryland enforcement authorities as arbiters in an international conflict between Israelis and Palestinians. Though the bill's title would suggest that its focus is on "settler violence" in Israel, its overly broad language could arguably sweep up and impose severe penalties on many Jewish and pro-Israel nonprofit organizations (including their directors, officers

and employees) doing critical humanitarian work far removed from the conduct described in the bill.

Regardless of intent, this bill will also necessarily have a chilling effect on the work of these charitable organizations and the willingness of individuals to lead or work for them. We are deeply familiar with the complex issues surrounding Israel, and we are fierce advocates for dialogue that advances peace in the Middle East, including the two-state solution to the Israeli-Palestinian conflict. This bill does not achieve that goal. Instead, it sows greater division among Marylanders and distracts from the important work that our legislators do for our state each and every day.

We urge the House Judiciary Committee to give HB1394 an unfavorable report.

### **OPPOSE**

Agudath Israel of Maryland, the Mid-Atlantic regional office for Agudath Israel of America – a renowned national Jewish advocacy organization with chapters across the country speaks on behalf of the Orthodox Jewish communities across Maryland. Thousands of the members of our community have visited Israel, have lived in Israel, and/or have family members who live in Israel, and we speak on their behalf as well.

House Bill 1394 seeks to penalize nonprofit organizations if they engage in aiding or abetting certain activity by the government of Israel or a citizen of Israel relating to Israeli settlements. Jews lived in the West Bank, also known as Judea and Samaria, for thousands of years, and many of Judaism's holiest sites are located there. After the country of Jordan seized the area during the War of Israeli Independence, Jordan expelled all Jews (roughly seventeen thousand souls) from the area. Only after the Six Day War, when Israel successfully defeated a Jordanian attack and managed to expel Jordanian forces from the area, were Jews once allowed into the area. (To this day, Jews are unable to reside in areas controlled by the Palestinian Authority.) Included in this area is much of Jerusalem, including the Temple Mount and the Western Wall, which are considered the holiest place on Earth in the Jewish tradition.

House Bill 1394 is merely another attempt to continue to unfairly demonize Israel. House Bill 1394 assumes that Israelis should not be allowed to establish residence in some of Judaism's most holy places, and nonprofits supporting a Jewish presence in areas such as the Western Wall (!) should be punished. We urge an unfavorable report on House Bill 1394. Thank you.

## Judiciary Committee March 5, 2025 OPPOSE

Background: House Bill 1394 (HB1394) seeks to revoke the tax-exempt status of nonprofits that support Israel as defined in the bill. Though the bill's title would suggest that its focus is on "settler violence" in Israel, its overly broad language could arguably sweep up and impose severe penalties on many Jewish and pro-Israel nonprofit organizations (including their directors, officers, and employees) doing critical humanitarian work far removed from the conduct described in the bill. This legislation unjustly targets one specific country (and Jewish nonprofits) when there are already laws in place to prevent not-for-profit organizations from engaging in illegal activity. The legislation would allow anyone to sue an organization for violating the proposed legislation, not just the government or the Maryland Attorney General. This opens the floodgates for lawsuits from anyone with a political agenda, regardless of any merit the lawsuit may have.

**Written Comments:** The Baltimore Jewish Council (BJC) represents The Associated: Jewish Federation of Baltimore, all of its agencies, as well as the organized Jewish Community of Greater Baltimore. We are adamantly opposed to this ill-informed bill which targets the only Jewish State in the world and Jewish nonprofit organizations. There are thousands of nonprofits that the bill sponsor, the BJC, and anyone may not support, but does that mean we should start taking away the 501c3 status of any organization that any legislator finds offensive?

In the United States, you may disagree with the purposes of the The National Right to Life Educational Foundation Inc. (pro-life advocacy), Vdare Foundation (an anti-immigrant and white supremacist hate group), and/or the Alliance Defending Freedom (American conservative Christian legal advocacy group advocating against the LGBTQ+ community and others), but this bill does not target those groups. You may also oppose the business relationships U.S. nonprofits have with foreign authoritarian regimes and dictators, like the U.S.-Russia Business Council and/or U.S. China Business Council, but this bill does not target these nonprofits. Instead, this bill focuses on the only Democracy in the Middle East and the only Jewish state in world, and Jewish nonprofits.
