The State Board of Acupuncture, the State Board of Audiologists, Hearing Aid Dispensers, Speech/Language Pathologists & Music Therapists, the State Board of Chiropractic Examiners, the State Board of Long-Term Care Administrators, the State Board of Massage Therapy Examiners, the State Board of Morticians & Funeral Directors, the State Board of Occupational Therapy Practice, the State Board of Examiners in Optometry, the State Board of Physical Therapy Examiners, the State Board of Podiatric Medical Examiners, the State Board of Professional Counselors & Therapists, the State Board of Examiners of Psychologists, the State Board of Social Work Examiners, the State Commission on Kidney Disease is submitting this Letter of Concern for HB 231 – Constitutional Amendment – Fee or Tax Rate Increases – Yea and Nay Vote of General Assembly Required (Taxpayer Disclosure and Protection Act).

Currently, the health occupations Boards and Commission have the authority to set fees based on various health occupation statutes. It is unclear how HB 231 will impact that authority.

The Boards and Commission support transparency in the setting of fees. Fees are established in regulations, and there is already a public process in the State government for this. The Boards' and Commission's internal process ensures additional transparency. This includes discussions in open public meetings, postings on the Boards' and Commission's website, and stakeholders are consulted.

Most Boards are special-funded and rely on licensure fees to fund their operations. Any potential delays to the already established process could have a significant negative impact on the Boards and Commission and their ability to function.
