RE: HB0091 Elections - In person Voting - Proof of Identity

SUPPORT

Requiring a voter to present a photo ID preserves the integrity of every voter's vote and protects the integrity of the election itself.

- Currently, anyone who knows a registered voter's name, address, and month/day of birth can walk-in and vote as that person on a regular ballot. No one is verifying signatures on the VACs (Voter Authority Cards). When an individual votes on a regular ballot, it is permanent. There is no way to remove this vote once it has been cast.
- By requiring a voter to present photo ID, the integrity of the election is also preserved. At least 12 other states require some form of ID and 23 states requiring a photo ID in order to vote a regular ballot. Maryland is among 15 states that require **NO ID** to vote.

When Valid IDs Are NOT Required:

- > The above chart lists over 60 instances where a valid Identification Card is required, yet not for Voting.
- As an Election Judge for several election cycles I can affirm that voters actually want to show their ID and most certainly let us know that they think is it ridiculous that to show an ID to vote is NOT required in Maryland.
- Requiring a voter ID ensures that voters' rights are protected. Disenfranchisement of voters' rights only fosters distrust of our election system and reduces voter confidence.
- No one is blocked by requiring an ID as they are easy and free to obtain through the Motor Vehicles Administration.
- Many employees already have a photo ID as even all elected officials and state and federal employees, as well as anyone who drives any type of motor vehicle do.

A 2024 Pew Research Poll showed that 81% of those surveyed supported voter ID laws that required proof of identity in order to vote. The breakdown by party is overwhelming favorable with 95% of Republicans, and 69% of Democrats favoring voter ID (an increase from 61% in 2023).

Maryland needs to join with nearly half of all 50 states that require a voter ID to vote.

Therefore, I respectfully request a **Favorable Report for HB0091** because this Bill is necessary to preserve, protect, and respect the rights of all registered voters.
