# AMENDMENTS TO HOUSE BILL 856

(First Reading File Bill)

# AMENDMENT NO. 1

On page 1, in line 2, strike "Horse Racing" and substitute "State Lottery Fund"; strike beginning with "Distribution" in line 2 down through "Alterations" in line 3 and substitute "Fair Hill Natural Resources Management Area – Funding"; strike beginning with "altering" in line 4 down through "Account" in line 5 and substitute "requiring the Comptroller to distribute in certain fiscal years a certain amount from the State Lottery Fund to the Department of Natural Resources to be used for certain purposes at the Fair Hill Natural Resources Management Area"; strike beginning with "Racetrack" in line 5 down through "Account" in line 6 and substitute "State Lottery Fund and the Fair Hill Natural Resources Management Area"; strike in their entirety lines 7 through 11, inclusive; in line 14, strike "9–1A–29(d) and (h)" and substitute "9–120(b)(1)(xiii) and (xiv)"; and after line 16, insert:

## "BY adding to

<u>Article – State Government</u>

Section 9-120(b)(1)(xiv)

Annotated Code of Maryland

(2021 Replacement Volume and 2024 Supplement)".

### AMENDMENT NO. 2

On pages 1 through 3, strike in their entirety the lines beginning with line 20 on page 1 through line 26 on page 3, inclusive.

On page 3, after line 26, insert:

"9–120.

(b) (1) By the end of the month following collection, the Comptroller shall deposit, cause to be deposited, or pay:

(xiii) after June 30, 2024, a supplemental local impact grant of \$3,000,000 each fiscal year to the County Executive and County Council of Prince George's County from the money that remains in the State Lottery Fund from the proceeds of all lotteries after the distributions under subsection (a) of this section and items (i) through (xii) of this paragraph to be distributed in Prince George's County in accordance with § 9–1A–31 of this title; [and]

(XIV) AFTER JUNE 30, 2025, BUT NOT LATER THAN JUNE 30, 2030, TO THE DEPARTMENT OF NATURAL RESOURCES TO BE USED FOR THE ONGOING OPERATION, USE, MAINTENANCE, AND DEVELOPMENT OR IMPROVEMENT OF THE GROUNDS AND FACILITIES WITHIN THE SPECIAL EVENT ZONE AT THE FAIR HILL NATURAL RESOURCES MANAGEMENT AREA, FROM THE MONEY THAT REMAINS IN THE STATE LOTTERY FUND FROM THE PROCEEDS OF ALL LOTTERIES AFTER THE DISTRIBUTIONS UNDER SUBSECTION (A) OF THIS SECTION AND ITEMS (I) THROUGH (XIII) OF THIS PARAGRAPH, AN AMOUNT EQUAL TO \$850,000 IN EACH FISCAL YEAR; AND

[(xiv)] (XV) into the General Fund of the State the money that remains in the State Lottery Fund from the proceeds of all lotteries after the distributions under subsection (a) of this section and items (i) through [(xiii)] (XIV) of this paragraph."
