HB0282 – Public Schools - Sexually Explicit Materials - Prohibited in Libraries and Media Centers

#### Position: UNFAVORABLE

Chair Atterbeary, Vice Chair Wilkins, and Esteemed Members of the Ways and Means Committee:

My name is Ronnie L. Taylor, and I serve as the Community Advocacy Manager at FreeState Justice, a nonprofit organization dedicated to advocating for LGBTQ+ rights in Maryland. I write in strong opposition to **HB0282**, a bill that, while framed as an effort to regulate "sexually explicit" materials in public school libraries and media centers, instead poses a serious threat to academic freedom, inclusivity, and the rights of LGBTQ+ students in Maryland.

**HB0282** is a thinly veiled book banning effort that would disproportionately impact LGBTQ+ content, reproductive health education, and historical narratives that do not conform to a narrow moral viewpoint. Censorship bills like **HB0282** have been used across the country to erase LGBTQ+ experiences from educational spaces, leaving LGBTQ+ youth isolated and without resources that affirm their identities.

Numerous studies highlight the dangers of limiting access to diverse materials in schools:

- According to the American Library Association (ALA), 49% of banned books in 2023 contained LGBTQ+ themes. These bans disproportionately impact LGBTQ+ students, making them feel invisible in educational settings.
- The Trevor Project's 2023 National Survey found that 45% of LGBTQ+ youth seriously considered suicide in the past year, with access to affirming educational materials significantly reducing these rates.

• Censorship efforts disproportionately impact students of color, as books addressing race, systemic inequities, and intersectional experiences are also targeted for removal.

### Concerns with HB0282:

## 1. Vague Language Leads to LGBTQ+ Censorship

- The bill defines "sexually explicit materials" as those that contain "graphic or obscene depictions of sexual activity" but does not specify how "graphic" or "obscene" are determined. Historically, similar language has been weaponized to remove books featuring LGBTQ+ identities, even when those books contain no explicit content.
- For example, Gender Queer by Maia Kobabe and All Boys Aren't Blue by George M. Johnson have been removed from school libraries under similar laws in other states, even though they primarily discuss personal identity and self-discovery.

#### 2. Targeting LGBTQ+ Educational Resources and Health Education

- Maryland schools are required to provide comprehensive health education, which includes age-appropriate discussions on human sexuality, reproductive health, and LGBTQ+ identities.
- Bills like **HB0282** have been used in other states to remove factual books on LGBTQ+ relationships, safe sex practices, and gender identity, depriving students of life-saving, medically accurate information.

## 3. Violates the First Amendment and Creates Unnecessary Bureaucracy

- The American Civil Liberties Union (ACLU) and federal courts have consistently ruled against vague censorship laws in schools, citing First Amendment concerns.
- Local school districts already have policies in place for selecting appropriate materials, making this legislation unnecessary and costly to implement.

#### 4. Harmful Impact on Students

- Removing LGBTQ+ materials sends a clear message to queer students: your identity is not acceptable, and your experiences do not belong in the classroom. This fosters a hostile environment, leading to increased mental health challenges.
- School libraries serve all students, not just those whose parents seek to impose restrictive moral viewpoints. If a parent objects to a book, they already have the right to restrict their own child's access—but they should not dictate what is available to an entire student body.

**HB0282** is not about protecting students—it is about silencing marginalized voices and advancing a political agenda that seeks to erase LGBTQ+ identities from public schools. Instead

of passing laws that stigmatize and isolate vulnerable youth, we should be investing in inclusive education that fosters belonging, academic curiosity, and critical thinking.

I urge this committee to reject **HB0282** and uphold Maryland's commitment to diversity, equity, and inclusion in education.
