A BILL ENTITLED

1 AN ACT concerning

2 **Public Libraries - Automated External Defibrillator Program**  
3 **(Raymono A. Russell Act)**

4 FOR the purpose of requiring operators of certain libraries, beginning on a certain date, to  
5 place an automated external defibrillator in a certain area, maintain the  
6 functionality of the automated external defibrillator, and ensure a trained individual  
7 is present under certain circumstances; granting certain immunities to libraries and  
8 individuals for certain acts or omissions under certain circumstances; ~~altering the~~  
9 ~~definition of "facility" for the purpose of excluding certain libraries from the Public~~  
10 ~~Access Automated External Defibrillator Program; requiring the Maryland~~  
11 ~~Department of Health and the Maryland Institute for Emergency Medical Services~~  
12 ~~Systems jointly to adopt certain regulations; and generally relating to an automated~~  
13 external defibrillator program for libraries.

17 **(2) "AUTOMATED EXTERNAL DEFIBRILLATOR (AED)" MEANS A**  
 18 **MEDICAL HEART MONITOR AND DEFIBRILLATOR DEVICE THAT:**

19 **(I) IS CLEARED FOR MARKET BY THE FEDERAL FOOD AND**  
 20 **DRUG ADMINISTRATION;**

21 **(II) RECOGNIZES THE PRESENCE OR ABSENCE OF**  
 22 **VENTRICULAR FIBRILLATION OR RAPID VENTRICULAR TACHYCARDIA;**

23 **(III) DETERMINES, WITHOUT INTERVENTION BY AN OPERATOR,**  
 24 **WHETHER DEFIBRILLATION SHOULD BE PERFORMED;**

25 **(IV) ON DETERMINING THAT DEFIBRILLATION SHOULD BE**  
 26 **PERFORMED, AUTOMATICALLY CHARGES; AND**

27 **(V) 1. REQUIRES OPERATOR INTERVENTION TO DELIVER**

- 4 1. THE STATE LIBRARY RESOURCE CENTER;
- 5 2. A REGIONAL RESOURCE CENTER;
- 6 3. A CORRECTIONAL FACILITY LIBRARY;
- 7 4. A COUNTY LIBRARY SYSTEM AND THE ENOCH PRATT  
8 FREE LIBRARY IN BALTIMORE;
- 9 5. THE MARYLAND STATE LIBRARY FOR THE BLIND  
10 AND PRINT DISABLED;
- 11 6. THE MARYLAND DEAF CULTURE DIGITAL LIBRARY;

3           **(I) THE INDIVIDUAL IS ACTING IN GOOD FAITH WHILE**  
 4 **RENDERING AUTOMATED EXTERNAL DEFIBRILLATION TO ANOTHER INDIVIDUAL**  
 5 **WHO IS THE VICTIM OR IS REASONABLY BELIEVED BY THE INDIVIDUAL TO BE A**  
 6 **VICTIM OF A SUDDEN CARDIAC ARREST;**

7           **(II) THE ASSISTANCE OR AID IS PROVIDED IN A REASONABLY**  
 8 **PRUDENT MANNER; AND**

9           **(III) THE AUTOMATED EXTERNAL DEFIBRILLATION IS PROVIDED**  
 10 **WITHOUT FEE OR OTHER COMPENSATION; AND**

11           **(3) A LIBRARY OR INDIVIDUAL IS NOT CIVILLY LIABLE FOR FAILING**  
 12 **TO RENDER AUTOMATED EXTERNAL DEFIBRILLATION TO AN INDIVIDUAL WHO IS A**

1           (1)     the libraries that registered automated external defibrillators in  
2 accordance with regulations adopted under § 23-102.2 of the Education Article, as enacted  
3 by Section 1 of this Act; and

4           (2)     the number of adverse cardiac events that required the use of an  
5 automated external defibrillator experienced in the libraries that registered the automated  
6 external defibrillators.

7           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
8 October 1, 2025.
