AMENDMENTS TO HOUSE BILL 337
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 6, after “year;” insert “requiring a county board to consult with certain municipalities and incorporate certain data when developing a local educational facilities master plan;”; strike beginning with “issuance” in line 8 down through “permits” in line 9 and substitute “initiation of construction”; and in line 13, after “4-148” insert “and 4-149”.

AMENDMENT NO. 2

On page 2, in line 8, after “MAP;” insert “AND”; strike beginning with “LOCATIONS” in line 9 down through “COUNTY” in line 11 and substitute “CENSUS TRACT AND BLOCK DATA REPORTED TO THE DEPARTMENT IN ACCORDANCE WITH § 4-113.1 OF THIS SUBTITLE”; and after line 16, insert:

“4-149.

(A) IN THIS SECTION, “LOCAL EDUCATIONAL FACILITIES MASTER PLAN” MEANS THE ANNUAL PLAN REQUIRED TO BE SUBMITTED TO THE INTERAGENCY COMMISSION ON SCHOOL CONSTRUCTION UNDER COMAR 14.39.02.03.

(B) IN DEVELOPING A LOCAL EDUCATIONAL FACILITIES MASTER PLAN, A COUNTY BOARD SHALL:

(1) CONSULT WITH EACH MUNICIPALITY LOCATED IN THE COUNTY THAT EXERCISES PLANNING AND ZONING AUTHORITY; AND

(2) INCORPORATE DATA PROVIDED BY THE MUNICIPALITIES INTO THE PLAN'S ENROLLMENT PROJECTIONS AND ANALYSIS OF FUTURE FACILITY NEEDS.

AMENDMENT NO. 3

On page 2, in line 19, strike "A COUNTY'S" and substitute "**IF A COUNTY ENACTS AN**"; strike beginning with "RESTRICTS" in line 19 down through "CAPACITY" in line 20 and substitute "**INCLUDES A DEFINITE MAXIMUM LENGTH OF TIME TO RESTRICT OR LIMIT HOUSING DEVELOPMENT ON THE BASIS OF SCHOOL CAPACITY, THE ORDINANCE**"; and in line 23, strike "ISSUANCE OF FINAL PERMITS" and substitute "**INITIATION OF CONSTRUCTION**".
