AMENDMENTS TO SENATE BILL 18
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, strike “**Revisions**” and substitute “**Practice-Based Conditional Licensure**”; strike beginning with “altering” in line 4 down through “work;” in line 5; in line 6, strike “alternate pathways” and substitute “a conditional social work license”; in line 6, strike “a” and substitute “the”; in line 7, after “license” insert “by completing certain supervised experience”; in line 10, strike “ (c-1),”; and in line 15, after “Section” insert “19-101(c-1) and”; and after line 17, insert:

“BY adding to

Article - Health Occupations

Section 19-309.2

Annotated Code of Maryland

(2021 Replacement Volume and 2025 Supplement)”.

AMENDMENT NO. 2

On page 2, in line 2, before “of” insert “**OR § 19-309.2**”; and after line 12, insert:

“19-309.1.

(a) If an administrative delay for any reason or an unforeseen circumstance, act, or occurrence prevents an examination required under this subtitle from being available to an applicant for a period of at least 15 business days, the Board may issue a conditional license UNDER THIS SECTION to an applicant who, except for passing the examination, has met the appropriate education and experience requirements of this subtitle for a license issued under § 19-302 of this subtitle to practice:

(1) Bachelor social work; or

(2) Master social work.

(b) A conditional license issued under this section authorizes the holder to practice social work in the State only under the supervision of a Board-approved supervisor while the conditional license is effective.

(c) A conditional license **ISSUED UNDER THIS SECTION** is valid until 180 days after the examination becomes readily available to the applicant.

(d) On or before December 31 each year, beginning in 2024, the Board shall report to the Senate Finance Committee and the House Health and Government Operations Committee, in accordance with § 2-1257 of the State Government Article, the following information for the immediately preceding 12-month period:

(1) Whether the examination was unavailable at any time during the reporting period; and

(2) If the examination was unavailable:

(i) The number of applicants who were eligible for a conditional license **UNDER THIS SECTION** due to the unavailability of the examination;

(ii) The number of applicants who applied to take the examination;

(iii) The number of applications that were delayed in processing;
and

(iv) The number of conditional licenses issued under this section.

19-309.2.

(A) THE BOARD SHALL ISSUE A CONDITIONAL LICENSE UNDER THIS SECTION TO AN APPLICANT WHO, EXCEPT FOR PASSING THE EXAMINATION OTHERWISE REQUIRED UNDER THIS SUBTITLE, HAS MET THE APPROPRIATE EDUCATION AND EXPERIENCE REQUIREMENTS OF THIS SUBTITLE FOR A LICENSE ISSUED UNDER § 19-302 OF THIS SUBTITLE TO PRACTICE:

(1) BACHELOR SOCIAL WORK; OR

(2) MASTER SOCIAL WORK.

(B) A CONDITIONAL LICENSE ISSUED UNDER THIS SECTION:

(1) AUTHORIZES THE HOLDER TO PRACTICE SOCIAL WORK IN THE STATE ONLY WITHIN THE SCOPE OF THE SPECIFIC CATEGORY OF LICENSE ISSUED BY THE BOARD;

(2) REQUIRES THE HOLDER TO PRACTICE UNDER THE SUPERVISION OF A BOARD-APPROVED SUPERVISOR IN ACCORDANCE WITH REGULATIONS ADOPTED UNDER THIS SECTION; AND

(3) MAY BE ISSUED ONLY TO AN INITIAL APPLICANT FOR LICENSURE WHO HAS NOT PREVIOUSLY BEEN LICENSED UNDER THIS TITLE.

(C) A CONDITIONAL LICENSE UNDER THIS SECTION:

(1) EXPIRES ON A DATE SET BY THE BOARD THAT IS AT LEAST 12 MONTHS, BUT NOT MORE THAN 24 MONTHS, AFTER THE DATE OF ISSUANCE;

(Over)

(2) MAY NOT BE RENEWED; AND

(3) SHALL TERMINATE AUTOMATICALLY ON:

(i) THE EXPIRATION DATE; OR

(ii) IF THE HOLDER APPLIES AND QUALIFIES FOR A LICENSE UNDER SUBSECTION (E) OF THIS SECTION, THE DATE THAT THE FULL LICENSE IS ISSUED.

(D) A HOLDER OF A CONDITIONAL LICENSE UNDER THIS SECTION AND THE SUPERVISING SOCIAL WORKER ARE JOINTLY RESPONSIBLE FOR ENSURING COMPLIANCE WITH THE SUPERVISION AND EXPIRATION REQUIREMENTS OF SUBSECTIONS (B)(2) AND (C) OF THIS SECTION.

(E) THE BOARD SHALL ISSUE A FULL LICENSE UNDER § 19-302 OF THIS SUBTITLE TO A HOLDER OF A CONDITIONAL LICENSE UNDER THIS SECTION WHO DEMONSTRATES TO THE SATISFACTION OF THE BOARD THAT THE HOLDER HAS:

(1) ACHIEVED A SATISFACTORY SCORE ON AN EXAMINATION, AS REQUIRED UNDER § 19-302 OF THIS SUBTITLE; OR

(2) COMPLETED AT LEAST 1,500 HOURS OF SUPERVISED EXPERIENCE IN THE PRACTICE OF SOCIAL WORK DURING THE PERIOD OF CONDITIONAL LICENSURE, AS VERIFIED BY A BOARD-APPROVED SUPERVISOR, IN ACCORDANCE WITH STANDARDS ESTABLISHED BY THE BOARD, IN CONSULTATION WITH AN INSTITUTION THAT:

(I) IS ACCREDITED BY THE COUNCIL ON SOCIAL WORK EDUCATION OR AN EQUIVALENT ORGANIZATION APPROVED BY THE COUNCIL ON SOCIAL WORK EDUCATION; AND

(II) OFFERS BOTH A BACCALAUREATE DEGREE AND A MASTER'S DEGREE.

(F) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION, INCLUDING REGULATIONS THAT ESTABLISH:

(1) MINIMUM SUPERVISION REQUIREMENTS AND REPORTING PROCEDURES;

(2) STANDARDS FOR EVALUATING SUPERVISED PRACTICE AS DESCRIBED IN SUBSECTION (E)(2) OF THIS SECTION;

(3) REQUIREMENTS TO ENSURE THAT THE TRACKING OF CONDITIONAL LICENSES ISSUED UNDER THIS SECTION ALIGNS WITH EXISTING LICENSURE CYCLES; AND

(4) A REASONABLE FEE FOR THE ISSUANCE OF A CONDITIONAL LICENSE ISSUED UNDER THIS SECTION SUFFICIENT TO COVER ADMINISTRATIVE COSTS.

(G) ON OR BEFORE DECEMBER 31 EACH YEAR, BEGINNING IN 2026, THE BOARD SHALL REPORT TO THE SENATE FINANCE COMMITTEE AND THE HOUSE HEALTH COMMITTEE, IN ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, THE FOLLOWING INFORMATION FOR THE IMMEDIATELY PRECEDING 12-MONTH PERIOD:

(Over)

(1) THE NUMBER OF CONDITIONAL LICENSES ISSUED UNDER THIS SECTION;

(2) THE NUMBER OF HOLDERS OF CONDITIONAL LICENSES WHO OBTAINED FULL LICENSURE UNDER SUBSECTION (E) OF THIS SECTION; AND

(3) ANY RECOMMENDATIONS FOR IMPROVING:

(I) THE IMPLEMENTATION OF THIS SECTION; AND

(II) THE IMPACT OF THIS SECTION ON THE HEALTH CARE WORKFORCE.
