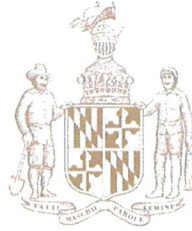

RE: Letter of Support – Senate Bill 414 – Consumption-Only Nonprofit Swim Club License

The Board of License Commissioners for Anne Arundel County respectfully submits this letter in strong support of Senate Bill 414.

This legislation establishes a narrowly tailored, consumption-only license for nonprofit swim clubs, allowing members and their guests to bring alcoholic beverages onto the premises for on-site consumption during designated events. The proposal provides a clear and lawful structure for an activity that community organizations have requested while maintaining the Board's oversight and regulatory authority.

Senate Bill 414 aligns with the Board's mission to administer the alcoholic beverage laws in a manner that is fair, practical, and responsive to the needs of Anne Arundel County residents. The license is limited in scope, applies only to nonprofit entities, and carries a modest annual fee. It does not create any fiscal or operational burden on the Board, as the application and review process is consistent with procedures already in place for similar authorizations.

Most importantly, this measure provides nonprofit swim clubs with a responsible and clearly defined path to host member events while ensuring that appropriate safeguards and accountability remain in place.

For these reasons, the Board respectfully urges a favorable report on Senate Bill 414.
