WRITTEN TESTIMONY

**House Bill 1382 State Procurement - Prohibited Certifications - Boycotts
of Foreign Countries**

Government, Labor, and Elections Committee

March 11, 2026

OPPOSE

Background: House Bill 1382 (HB1382) seeks to revoke a 2017 executive order prohibiting executive branch agencies from entering contracts or conducting official state business with an entity unless the entity certifies that they will not engage in the boycott of Israel. Boycott of Israel is defined in the executive order as the termination of or refusal to transact business activities, or other actions intended to limit commercial relations with a person or entity because of its Israeli national origin, or residence or incorporation in Israel and its territories. This would include boycotting a Maryland business because the Maryland business is owned by someone who happens to be of Israeli origin. It is the policy of the State of Maryland that such boycotts are inconsistent with Maryland's values and this bill aims to attack this policy.

The proponents of this bill support the Boycott Divestment and Sanctions (BDS) movement against Israel. BDS is an international campaign to delegitimize and pressure Israel, through the diplomatic, financial, professional, academic and cultural isolation of Israel, Israeli individuals, Israeli institutions, and, increasingly, Jews who support Israel's right to exist¹. Omar Barghouti, co-founder, and leader of the BDS movement has stated "We oppose a Jewish state in any part of Palestine... [only] a sellout Palestinian would accept a Jewish state in Palestine."²

Importantly, the BDS campaign does not support real measures to build a path forward in Israeli-Palestinian peace negotiations. BDS is a biased approach to the conflict, putting the fault of territorial claims of only one party, the only Jewish state, Israel, while ignoring the actions of Palestinians and others in the conflict. Simply put, "BDS advocates for self-determination for Palestinians while denying to Jews that same right."³

organized Jewish Community of Greater Baltimore. For more than three decades, Maryland and the Jewish community have jointly invested in developing a flourishing business relationship between our state and Israel creating jobs and economic activity both here and there. As part of that relationship in 2017 Governor Hogan signed an executive order to align with the state's values. This has been strongly reaffirmed by Governor Moore, who has stated "I am affirmatively against the Boycott, Divestment and Sanctions (BDS) movement. I will support the continuation of this executive order and I firmly believe that our laws should reflect our values. HB1382 seeks to reverse these values by targeting the only Jewish state and Jewish people in Maryland.

For these reasons we urge an unfavorable report on HB1382.
