## A BILL ENTITLED

1 AN ACT concerning

2 ~~Clinical Professional Counseling – Provision of Telehealth by Out-of-State Providers – Use of~~

5 FOR the purpose of ~~repealing the authority of the State Board of Professional Counselors~~  
6 ~~and Therapists to issue a temporary telehealth license; exempting certain State~~  
7 ~~licensure requirements for certain individuals who are licensed in another state and~~  
8 ~~who provide counseling through telehealth to clients in the State altering the~~  
9 ~~individuals to whom a temporary health license may be issued by the State Board of~~  
10 ~~Professional Counselors and Therapists, the services that a holder may provide through~~  
11 ~~telehealth, and to whom the services may be provided; and generally~~  
12 relating to clinical professional counseling and telehealth.

19 may not practice, attempt to practice, or offer to practice clinical alcohol and drug  
20 counseling, clinical marriage and family therapy, clinical professional art therapy, or  
21 clinical professional counseling in the State unless licensed by the Board.22 (b) Subject to the regulations of the Board, subsection (a) of this section does not  
23 apply to:24 (1) A student working under the supervision of a licensed mental health  
25 care provider while pursuing a supervised course of study in counseling that the Board  
26 approves as qualifying training and experience under this title; ~~‡or‡~~27 (2) An individual who, in accordance with § 17-406 of this title, is working  
28 as a trainee under the supervision of a licensed clinical alcohol and drug counselor or

 17 individual who is duly licensed under this article.

19 (a) ~~(1)~~ In this section ~~the following words have the meanings indicated,~~ “PROVIDE  
PROFESSIONAL COUNSELING OR THERAPEUTIC SERVICES” MEANS TO PRACTICE:

- (1) CLINICAL ALCOHOL AND DRUG COUNSELING;
- (2) CLINICAL MARRIAGE AND FAMILY THERAPY;
- (3) CLINICAL PROFESSIONAL ART THERAPY;
- (4) CLINICAL PROFESSIONAL COUNSELING;
- (5) GRADUATE ALCOHOL AND DRUG COUNSELING;
- (6) GRADUATE MARRIAGE AND FAMILY THERAPY;
- (7) GRADUATE PROFESSIONAL ART THERAPY; OR
- (8) GRADUATE PROFESSIONAL COUNSELING.

22 ~~(3) “Student” means an out-of-state resident enrolled at and residing at or~~  
 23 ~~near an institution of higher education in the State.~~

24 (b) The Board may issue a temporary telehealth license to an applicant who:

25 (1) Is not licensed, certified, or otherwise authorized by law to ~~practice~~  
 26 ~~clinical~~ PROVIDE professional counseling OR THERAPEUTIC SERVICES in the State under this  
 article;

27 (2) Is licensed, certified, or otherwise authorized by law to provide ~~clinical~~  
 28 professional counseling or ~~counseling~~ THERAPEUTIC services in another state;

- (3) Is in good standing with the regulatory authority in the other state;

1 (4) Meets any other qualifications set by the Board in regulations; and

2 (5) Submits a temporary telehealth license application.

3 (c) A temporary telehealth license issued under this section authorizes the holder  
4 to provide ~~clinical~~ professional counseling **OR THERAPEUTIC** services **CONSISTENT WITH THE SCOPE**  
5 **OF THE HOLDER'S OUT-OF-STATE AUTHORIZATION TO PRACTICE** through telehealth in the State only to  
6 a ~~student attending an institution of higher education~~ **CLIENT** in the State if the ~~student~~  
7 **CLIENT** and the  
8 out-of-state licensed ~~professional~~ counselor **OR THERAPIST** have a previously established  
9 therapeutic  
10 relationship that has existed for at least 6 months.

11 (d) The term of a temporary telehealth license issued under this section is 6  
12 months.

13 (e) A temporary telehealth license issued under this section may not be renewed.

14 (f) If the holder of a temporary telehealth license violates this title, the Board  
15 may not issue the individual a regular license under this title for at least 2 years after the  
16 date on which the violation occurred.

17 (g) The Board shall adopt regulations:

18 (1) To establish qualifications and application fees for a temporary  
19 telehealth license issued under this section;

20 (2) To establish any conditions or limitations applicable to a temporary  
21 telehealth licensee; and

22 (3) Necessary for the implementation, administration, and enforcement of  
this section.†

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
October 1, 2026.
