AMENDMENTS TO HOUSE BILL 1483
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Clinical**”; in the same line, after “**Counseling** –” insert “**Provision of Telehealth by**”; strike beginning with “**Use**” in line 2 down through “**Care**” in line 3 and substitute “**Expansion**”; strike beginning with “repealing” in line 4 down through “State” in line 7; in line 7, after “State” insert “altering the individuals to whom a temporary health license may be issued by the State Board of Professional Counselors and Therapists, the services that a holder may provide through telehealth, and to whom the services may be provided”; in line 11, strike “17–101(a)” and substitute “17–101(a), (l), and (cc) and 17–301”; in line 16, strike “17–101(l) and 17–301” and substitute “17-304.2”; and strike in their entirety lines 19 through 23, inclusive.

AMENDMENT NO. 2

On page 2, in lines 3, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, and 26, in each instance, strike the bracket; and in lines 5, 6, 7, 8, 9, 10, 11, and 12, strike “(1)”, “(2)”, “(3)”, “(4)”, “(5)”, “(6)”, “(7)”, and “(8)”, respectively.

On page 3, strike beginning with “; OR” in line 3 down through “STATE” in line 15; in line 18, strike the bracket; in line 19, strike “(1)”; in the same line, strike “the following words have the meanings indicated” and substitute “, “PROVIDE PROFESSIONAL COUNSELING OR THERAPEUTIC SERVICES” MEANS TO PRACTICE:

(1) CLINICAL ALCOHOL AND DRUG COUNSELING;

(2) CLINICAL MARRIAGE AND FAMILY THERAPY;

- (3) CLINICAL PROFESSIONAL ART THERAPY;
- (4) CLINICAL PROFESSIONAL COUNSELING;
- (5) GRADUATE ALCOHOL AND DRUG COUNSELING;
- (6) GRADUATE MARRIAGE AND FAMILY THERAPY;
- (7) GRADUATE PROFESSIONAL ART THERAPY; OR
- (8) GRADUATE PROFESSIONAL COUNSELING”;

strike beginning with “(2)” in line 20 down through “State.” in line 23; strike beginning with “practice” in line 25 down through “clinical” in line 26 and substitute “**PROVIDE**”; in line 26, after “counseling” insert “**OR THERAPEUTIC SERVICES**”; in line 27, strike “clinical”; and in line 28, strike the second “counseling” and substitute “**THERAPEUTIC**”.

On page 4, in line 4, strike “clinical”; in the same line, after “counseling” insert “**OR THERAPEUTIC**”; in the same line, after “services” insert “**CONSISTENT WITH THE SCOPE OF THE HOLDER’S OUT-OF-STATE AUTHORIZATION TO PRACTICE**”; in line 5, strike “student attending an institution of higher education” and substitute “**CLIENT**”; in the same line, strike the second “student” and substitute “**CLIENT**”; in line 6, strike “professional”; in the same line, after “counselor” insert “**OR THERAPIST**”; and in line 20, strike the bracket.
