The Maryland Legislative Agenda for Women (MLAW) is a statewide coalition of women's groups and individuals formed to provide a non-partisan, independent voice for Maryland women and families. MLAW's purpose is to advocate for legislation affecting women and families. To accomplish this goal, MLAW creates an annual legislative agenda with issues voted on by MLAW members and endorsed by organizations and individuals from all over Maryland. **SB245 - Public Safety - Immigration Enforcement Agreements – Prohibition** is a priority on the [2026 MLAW Agenda](#) and we urge your support.

[SB245](#) aims to sunset and prohibit 287(g) agreements in the State of Maryland, which are agreements between local law enforcement agencies and Immigration and Customs Enforcement (ICE) that enhance collaboration in immigration enforcement activities. The recent ramping up of ICE activities in Maryland and across the country has demonstrated how this impacts women by separating families and causing stress and trauma. This legislation serves as just one counter to the expansion of ICE activities in our state.

Limiting the expansion of ICE activities in Maryland by prohibiting 287(g) collaboration with local law enforcement will serve as a counter to the federal government's deportation initiative. It will also serve to limit the further separation of families we are seeing as a result of these mass deportations.

For these reasons, MLAW strongly urges the passage of SB245.
