**Testimony of Jaime Contreras, 32BJ SEIU Executive Vice President**  
**Senate Judicial Proceedings Committee**  
**Senate Bill No. 245 - Favorable**  
**January 22, 2026**

Dear Honorable Chair Smith, Vice Chair Waldstreicher, and Members of the Committee,

32BJ SEIU offers favorable testimony in support of **SB 245 – Public Safety – Immigration Enforcement Agreements – Prohibition.**

32BJ SEIU is proud to stand in solidarity with the over one million immigrant workers residing in Maryland who live in constant fear of detention and deportation. As an organization that is dedicated to advancing and protecting worker rights, we strongly support and urge the passage of **SB 245.**

32BJ is the largest building service union in the country, representing over 185,000 members up and down the East Coast and over 3,700 members across Maryland. Our members are primarily immigrants and people of color, and make up the workforce of essential cleaners, door-people, airport workers, and other building service workers who keep our homes, workplaces, schools, and transportation hubs up and running.

With our dedicated members, we fight to build a just society where immigrants can live free of fear and are treated with dignity and respect. Unfortunately, communities nationwide are facing an unprecedented attack by U.S. Immigration and Customs Enforcement. Immigration arrests have tripled across the country, and Maryland has been no exception to this trend.<sup>i</sup> The current administration's immigration dragnet has left few communities unscathed. Our union family is no exception: multiple 32BJ members have been subjected to unjust detention by ICE.

At its core, **SB 245** is about upholding Maryland's values - fairness, dignity, and justice for all. This bill affirms that our state should not be in the business of tearing families apart, undermining public trust, or diverting state and local resources into federal immigration enforcement. Instead, Maryland should remain focused on community safety, due process, and equal treatment under the law by prohibiting immigration enforcement agreements such as 287(g).

Over the past year, increasingly reckless federal immigration policy has sown fear and distrust across our union's membership and damaged the broader social fabric that holds our state together. Although President Trump claimed that ICE would be targeting "dangerous criminals,"<sup>ii</sup> seventy three percent of those detained since October of last year had no criminal conviction and only five

percent had been convicted of a violent crime.<sup>iii</sup> Due to this indiscriminate persecution, workers across Maryland are increasingly hesitant to show up for their jobs, employers are seeing disruption and uncertainty in their workplaces, and violations of labor and wage laws are going unaddressed because workers fear that speaking up could put themselves or their families at risk.

The 287(g) program has a documented history of racial profiling, discrimination, and wrongful detention. It diverts local law enforcement away from their primary role of protecting public safety and erodes trust between law enforcement and immigrant communities. When trust is broken, community safety suffers.

This climate of fear undermines basic workplace accountability. Retaliation—or the fear of it—is the primary reason workers do not report abuse. When immigration enforcement activity escalates, especially where it intersects with state or local law enforcement, unethical employers are effectively given cover to exploit vulnerable workers.<sup>iv</sup> That exploitation does not stop with immigrant workers; it threatens safety and standards across entire sectors. Clear protections that separate immigration enforcement from workers' interactions with government are essential to ensuring that all workers can assert their rights without fear.

For these reasons, 32BJ SEIU urges the Senate Judicial Proceedings Committee to issue a **favorable report on SB 245**.
