Dear Chair Will Smith and Members of the Committee:

The Montgomery County Council is in strong support of SB 245.

This legislation is rooted in sound policy and constitutional principles. Immigration enforcement is, and must remain, a federal responsibility. When local law enforcement is drawn into civil immigration matters, it blurs jurisdictional lines and diverts limited resources away from core public-safety priorities, crime prevention, emergency response, and community trust and cooperation.

Extensive evidence confirms that community trust is essential to public safety. According to the U.S. DOJ, residents are far more likely to report crimes, assist investigators, and seek help when they trust that local police are focused on their safety rather than immigration enforcement. Conversely, where local authorities have been perceived as arms of federal immigration, immigrant communities, including mixed-status families and U.S. citizens, greatly reduce 911 calls, withhold cooperation in domestic-violence cases, and avoid engagement with law enforcement. Those dynamics compromise safety for the entire community.

SB 245 also responds to the fiscal and operational realities facing local governments. Immigration-enforcement agreements such as 287(g) impose substantial costs, training, supervision, detention, and legal liabilities, while federal reimbursement remains limited and uncertain. Moreover, these programs can expose counties and municipalities to civil-rights litigation, reducing public confidence in government.

Crucially, SB 245 does not limit cooperation with federal authorities on serious criminal matters. Local agencies would retain full authority to share information and work jointly with federal officials where appropriate. The legislation draws the line specifically at delegating civil immigration authority, an approach that research and practical experience show does not reduce crime, but rather erodes trust and safety in communities.


