- Case Management Software (CMS)
 - Relational Databases
 - Centralize information, automate tasks, track cases, manage complex data, etc.
 - Detailed data on case processing decisions





- Charge Reductions and Sentencing Outcomes
 - Number, type and severity of charges, charge alterations, sentencing data



 - MCSAO Circuit Court cases 2018-2022







Court Appearance Rates Pre-/Post- Court Date Reminder Program





Speedy Contact with Victims

This chart shows the average number of days from case filing to first contact with the victim on a Victim Rights Act (VRA) case. Quicker contact with victims is beneficial to both victims and prosecutors.



Time to first contact is set to 0 days for cases with contact prior to case filing. Cases grouped by filing date.



- Communicating with the public

Milwaukee Criminal Convictions for Possession of Marijuana Have **Dropped** Since 2010.

Unlike statewide trends that decreased slightly over 10 years, Milwaukee County, in all marijuana possession conviction categories saw **well over 90% decreases** from 2010-2019.



Possession of marijuana includes possession of marijuana – 961.41(3g)(e) – and synthetic cannabinoids – 961.41(3g)(em).



Conviction for Violent Crimes

This chart shows the percent of violent crimes filed that result in a conviction. Frequent acquittals for violent crimes jeopardize public safety and community well-being. When prosecutors choose to bring a violent case to trial, they should ensure conviction.



 - Guidelines-eligible
 - Convicted Cases
 - Final Charges
 - No District Court



CONCLUSIONS

- Different Case Management Systems in MD
 - Detail and quality of data varies but similar information is available
- Broader Coverage of Criminal Cases
 - Arrest to sentencing for all District and Circuit Court cases
- Detailed Case Processing Information
 - Charge alterations, dismissal reasons, plea negotiation processes
- Multiple Applications
 - Public safety, fairness and equity, policy evaluation outcomes
 - Office efficiency, effectiveness, and transparency and accountability
