1 Section 1. Be It Enacted By The County Council of Harford County, Maryland that Section 244-  
2 20 (D), Parking fines, of Article IV, Citations and Penalties, be, and it is hereby, repealed and  
3 reenacted, with amendments, all of Chapter 244, Vehicles and Traffic, of the Harford County  
4 Code, as amended, and all to read as follows:

5 **Chapter 244. Vehicles and Traffic**

6 **Article IV. Citations and Penalties**


7 **§244-20. Parking fines.**

8 D. The fine for a parking violation in a handicapped parking area as set forth in §244-5  
9 is [~~\$120~~] \$140.

10 Section 2. And Be It Further Enacted that this Act shall take effect 60 calendar days from the  
11 date it becomes law.
