### A BILL ENTITLED

1 AN ORDINANCE concerning: Boards, Commissions, and Similar Bodies –  
2 Commission on Disability Issues

3  
4 FOR the purpose of amending the composition of the Commission on Disability Issues;  
5 amending the terms for membership on the Commission; amending the powers and  
6 duties of the Commission; making technical corrections; and generally relating to  
7 boards, commissions, and similar bodies.

8  
9 BY repealing and reenacting, with amendments: §§ 3-2B-102; 3-2B-103; 3-2B-104(a); 3-  
10 2B-107; and 3-2B-109  
11 Anne Arundel County Code (2005, as amended)

12  
13 BY adding: § 3-2B-104(d)  
14 Anne Arundel County Code (2005, as amended)

16 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
17 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

### 20 21 **TITLE 2B. COMMISSION ON DISABILITY ISSUES**

1 **3-2B-102. Purpose.**

2  
3 The purpose of the Commission is to promote and enhance the quality of life for  
4 **[[persons]] INDIVIDUALS** with disabilities by advising the County Executive and the  
5 County Council on the coordination and development of government policies, programs,  
6 services, and allocation of resources for **[[persons]] INDIVIDUALS** with disabilities and by  
7 proposing the means to meet the needs of **[[persons]] INDIVIDUALS** with disabilities.  
8

9 **3-2B-103. Composition.**

10  
11 (a) **Number and type of members.** The Commission consists of at least **[[28]]** 22  
12 members appointed by the County Executive. Of the members:  
13

14 (1) **[[twenty-one]] FIFTEEN** shall be voting members selected from the following  
15 groups: **[[persons]] INDIVIDUALS** with a disability, family members of **[[persons]]**  
16 **INDIVIDUALS** with a disability, representatives of organizations or agencies that provide  
17 services for or represent **[[persons]] INDIVIDUALS** with disabilities, persons interested in  
18 improving the quality of life for **[[persons]] INDIVIDUALS** with disabilities, or persons  
19 having expertise in matters pertaining to **[[persons]] INDIVIDUALS** with disabilities; and  
20

21 (2) at least seven shall be **[[ex officio]] NON-VOTING** members selected from any  
22 of the following entities and agencies or any other entity or agency that the County  
23 Executive deems appropriate: Anne Arundel County ADA Office, Department of Aging  
24 and Disabilities, Department of Inspections and Permits, Department of Public Works,  
25 Department of Recreation and Parks, Department of Social Services, Office of Planning  
26 and Zoning, Department of Health, County Council, and Police Department; Anne  
27 Arundel County Board of Education; Anne Arundel Community College; Anne Arundel  
28 County Mental Health Agency, Inc.; the Anne Arundel County Public Library; the State  
29 Department of Rehabilitation Services; and the City of Annapolis.  
30

31 (b) **Residency.** Each VOTING member shall be a resident of the County.  
32

33 (c) **ADA Coordinator.** THE ADA COORDINATOR IN THE DEPARTMENT OF AGING AND  
34 DISABILITIES SHALL SERVE AS THE LIAISON BETWEEN THE COMMISSION AND THE  
35 COUNTY EXECUTIVE AND THE DEPARTMENT OF AGING AND DISABILITIES. THE ADA  
36 COORDINATOR SHALL PROVIDE ADMINISTRATIVE ASSISTANCE TO THE COMMISSION.  
37

38 **3-2B-104. Term of members.**

39 (a) **Generally.**

40  
41  
42 (1) Of the voting members, **[[seven]] FIVE** shall be appointed for initial terms of  
43 three years, **[[seven]] FIVE** shall be appointed for initial terms of two years, and **[[seven]]**  
44 **FIVE** shall be appointed for initial terms of one year. After the expiration of the initial terms,  
45 **[[all terms]] VOTING MEMBERS** shall be APPOINTED for **[[three-year terms]] TERMS OF**  
46 **THREE YEARS.**  
47

48 (2) **[[Ex officio]] NON-VOTING** members shall serve at the pleasure of the County  
49 Executive.

1 (3) VOTING MEMBERS SHALL SERVE A MAXIMUM OF TWO CONSECUTIVE TERMS.  
2

3 (D) **Removal.** A MEMBER OF THE COMMISSION MAY BE REMOVED BY THE COUNTY  
4 EXECUTIVE FOR CAUSE, INCLUDING ABSENCE FROM 25% OR MORE OF THE SCHEDULED  
5 MEETINGS AND HEARINGS OF THE COMMISSION DURING ANY 12-MONTH PERIOD.  
6

7 **3-2B-107. Rules and regulations.**  
8

9 The Commission shall adopt rules and regulations to govern **[[its]]** procedures **[[and**  
10 activities**]]** FOR ITS MEETINGS.  
11

12 **3-2B-109. Powers and duties.**  
13

14 Among its powers and duties, the Commission shall:  
15

16 (1) review available services and activities for **[[disabled persons]]** INDIVIDUALS  
17 WITH DISABILITIES, gather data regarding their needs, and review reports and publications  
18 of governmental agencies that provide services and support to **[[persons]]** INDIVIDUALS  
19 with disabilities;  
20

21 (2) review County, State and federal legislation that may impact **[[persons]]**  
22 INDIVIDUALS with disabilities and make recommendations to the County Executive **[[,**  
23 County Council, and the County delegation to the State legislature**]]** regarding THE  
24 legislation;  
25

26 (3) **[[recommend ways of maximizing the use of facilities and services available to**  
27 persons with disabilities;  
28

29 (4)**]]** provide direct communication among **[[disabled persons]]** INDIVIDUALS WITH  
30 DISABILITIES, private and public organizations, and the general public regarding COUNTY  
31 programs and services for **[[persons]]** INDIVIDUALS with disabilities AS REQUESTED BY  
32 THE DEPARTMENT OF AGING AND DISABILITIES;  
33

34 **[[5]]** (4) assist interagency planning groups and special task forces to identify and  
35 assess needs of **[[persons]]** INDIVIDUALS with disabilities AS REQUESTED BY THE  
36 DEPARTMENT OF AGING AND DISABILITIES;  
37

38 **[[6]]** (5) identify COMMON barriers to **[[service delivery and advocate for]]**  
39 PROVISION OF services to **[[persons]]** INDIVIDUALS with disabilities in the County;  
40


41 **[[7 promote]]** (6) ADVISE THE COUNTY EXECUTIVE ON the coordination of  
42 services among all public and private agencies, departments, and organizations, which  
43 provide services and programs to **[[persons]]** INDIVIDUALS with disabilities; and  
44

45 **[[8]]** (7) identify and recommend to the County Executive sources of State and  
46 federal financial assistance available for the purpose of expanding or improving services  
47 and programs for **[[persons]]** INDIVIDUALS with disabilities.

1 SECTION 2. *And be it further enacted*, That this Ordinance shall take effect 45 days  
2 from the date it becomes law.
