4 FOR the purpose of revising the form of application for the public safety officer tax credit;
5 and generally relating to real property tax credits for public safety officers.

7 BY repealing and reenacting, with amendments: § 4-2-312(g)
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
11 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

12 13 **ARTICLE 4. FINANCE, TAXATION, AND BUDGET**

14 15 **TITLE 2. REAL PROPERTY TAXES**

16 17 **4-2-312. Public Safety Officers property tax credit.**

19 (g) **Form of application.** An application for, or for the renewal of, the Public Safety
20 Officer tax credit shall be made **[[as directed by the State Department of Assessments and**
21 **Taxation]] ON A FORM PROVIDED BY THE CONTROLLER'S OFFICE.**

23 SECTION 2. *And be it further enacted,* That this Ordinance shall take effect 45 days
24 from the date it becomes law.
