1 AN ORDINANCE concerning: Public Works – Utilities – Environmental Protection Fee

3 FOR the purpose of increasing the environmental protection fee for water and wastewater
4 service; providing for the effective date of this Ordinance; and generally relating to the
5 environmental protection fee.

7 BY repealing and reenacting, with amendments: § 13-5-808
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
11 That Sections of the Anne Arundel County Code (2005, as amended) read as follows:

ARTICLE 13. PUBLIC WORKS

TITLE 5. UTILITIES

13-5-808. Environmental protection fee.

19 (A) Except in the Mayo Water Reclamation Subdistrict, [a 25%] AN environmental
20 protection fee shall be added to all usage charges for both water and wastewater service,
21 except for the capital facility recoupment charge, to recover costs associated with
22 construction of, expansion of, and improvements to capital facilities to service existing
23 connected customers AT THE FOLLOWING RATES:

25 (1) 27.5%;

- 1 (2) 30%, BEGINNING ON JULY 1, 2020;

7 (B) Revenues accruing from this fee shall be dedicated for debt service of the water and
8 wastewater utility fund.


