4 FOR the purpose of allowing “private golf course facilities” as a conditional use in Open  
5 Space Districts; and generally relating to zoning.

7 BY repealing and reenacting, with amendments: § 18-9-202  
8 Anne Arundel County Code (2005, as amended)

10 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*  
11 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

#### 16 17 **18-9-202. Permitted, conditional, and special exception uses**

19 The permitted, conditional, and special exception uses allowed in Open Space Districts  
20 (OS) and in the Open Space Conservation Overlay (OS-C) are listed in the chart in this  
21 section using the following key: P = permitted use; C = conditional use; SE = special  
22 exception use. Except as provided otherwise in this article, uses and structures customarily  
23 accessory to the listed uses also are allowed.

Captions and taglines in **bold** in this bill are catchwords and are not law.



4 from the date it becomes law.






