A BILL  
ENTITLED

AN ACT concerning

Residential Permit Parking Areas

FOR the purpose of amending the Zones in which residential permit parking areas are permitted to include a certain Zone if the areas within the Zone are in residential use; and generally relating to residential permit parking areas.

BY repealing and re-enacting, with amendments

Sections 18-2-402(a) and 18-2-403(b)  
Article 18 – Transportation  
Title 2 – Vehicles and Traffic  
Subtitle 4 – Residential Permit Parking Areas

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND, that the Laws of Baltimore County read as follows:

6 Subtitle 4 – Residential Permit Parking Areas

8 § 18-2-402. Residential Permit Parking Area – Determination Procedure.

9 (a) A residential permit parking area may be established in a contiguous area containing  
10 streets or parts of streets primarily abutted by property that is in residential use and ZONED ~~R.O.~~  
11 R.O.A., OR IS IN RESIDENTIAL USE AND has the specific residential zones DR-1, DR-2,  
12 DR-3.5, DR-5.5, DR-10.5, and DR-16.

14 § 18-2-403. Same – Eligibility and Criteria.

15 (b) A residentially zoned area OR AN AREA THAT IS IN RESIDENTIAL USE AND  
16 ZONED R.O. may be deemed eligible for residential permit parking based on the criteria  
17 established in this section.

19 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by  
20 the affirmative vote of five members of the County Council, shall take effect on December 21,  
21 2020.
