# A BILL ENTITLED

#### AN ACT concerning

Zoning Regulations - Uses Permitted in Residential - Office and Office Zones

FOR the purpose of permitting a certain office/service use in the R-O (Residential – Office), OR-1 (Office Building – Residential), and OR-2 (Office Building – Residential) Zones; and generally relating to uses in the R-O, OR-1, OR-2 Zones.

BY adding

Sections 204.3.A.3, 205.3.A.5, and 206.3.A.8, Baltimore County Zoning Regulations, as amended

#### 1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE

2 COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:
