9	identified herein and accompanying this Act are hereby adopted and declared to be a part of this
10	Act and incorporated by reference herein. The following maps are hereby adopted and identified

6	Act, the Maps adopted hereby shall be signed by the Chairman of the County Council and shall be
7	dated as of the effective date of this Act and thereafter delivered to the Department of Permits.

10	SECTION 4. AND BE IT FURTHER ENACTED, that Subsection 4A02.3.A.1., 2. and
11	3. of the Baltimore County Zoning Regulations, be and they are hereby repealed and reenacted
12	with amendments, to read as follows:
