1 **WHEREAS**, the County Executive has recommended a supplemental appropriation to
2 the expense budget for the fiscal year ending June 30, 2020, in accordance with Section 517 of
3 the Charter of Harford County, Maryland; and

4 **WHEREAS**, such funds from the CARES Act are necessary to cover the County’s
5 expenses related to responding to the global COVID-19 pandemic and to assist businesses
6 effected by the pandemic; and

7 **WHEREAS**, such funds are necessary to cover estimated expenses incurred during
8 FY2020 attributable to anticipated retirements; and

9 **WHEREAS**, the Treasurer has certified that such funds are available for appropriation.

10 **NOW, THEREFORE,**

11 Section 1. Be It Enacted By The County Council of Harford County, Maryland, that the
12 expense budget for the fiscal year ending June 30, 2020, be, and it is hereby, amended by making

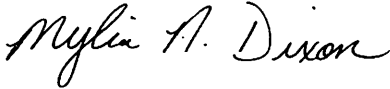
