### LEGISLATIVE BILL 2020-14

INTRODUCED BY: The President of the Council at the request of the Acting County Executive.

AN ACT TO REORGANIZE AND TRANSFER THE COUNTY PAYROLL FUNCTIONS AND PAYROLL PERSONNEL FROM THE DIRECTION AND CONTROL OF THE DEPARTMENT OF HUMAN RESOURCES TO THE DIRECTION AND CONTROL OF THE DEPARTMENT OF FINANCE.

WHEREAS, Wicomico County Charter Section 504(D)(2) provides that the reallocation of payroll functions and payroll personnel between the various departments is a reorganization; and

WHEREAS, the Department of Human Resources is currently responsible for the County payroll functions; and

WHEREAS, the Acting County Executive deems it to be in the best interest of efficient government that all payroll functions and payroll personnel be transferred from the Department of Human Resources to the Department of Finance to achieve operational efficiency and a smoother audit process; and

WHEREAS, based upon the favorable recommendation of the Acting County Executive to reorganize all County payroll functions by transferring all payroll functions and payroll personnel from the Department of Human Resources to the Department of Finance, the County Council enacts this Bill.

SECTION I: BE IT ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION, that County payroll functions and payroll personnel be transferred from the Department of Human Resources to the Department of Finance.

SECTION II: BE IT FURTHER ENACTED, that this Bill shall not be codified in the Wicomico County Code.

SECTION III: BE IT FURTHER ENACTED AND ORDAINED BY THE COUNTY COUNCIL OF WICOMICO COUNTY, MARYLAND, IN LEGISLATIVE SESSION THAT this bill shall be known as Legislative Bill No. 2020-14 and shall take effect sixty (60) days after its enactment, unless a proper Petition for Referendum thereof shall be filed prior to said date; in which event, the Bill shall not take effect until the expiration of thirty (30) days following the approval of this Bill by a majority of the qualified voters of the County voting in any such referendum.




**INTRODUCED BY:** President of the Council at the request of the Acting County Executive


**BY THE COUNCIL:**
