One member shall be recommended by the Agricultural LAND PRESERVATION ADVISORY BOARD Committee, one member shall be recommended by the Charles County Farm Bureau and three members shall be chosen at large by the Commissioners representing the entire County. Members of the Committee shall serve at the pleasure of the County Commissioners for two full four-year terms. Members shall have the option to be considered for reappointment, and
