5	FOR the purpose of amending the Capital Budget for the current fiscal year by making a
6	supplementary appropriation of funds to the Board of Education Security Related
7	Upgrades and Maintenance Backlog capital projects; amending the Capital Program
8	and Capital Projects Bond Ordinance for the current fiscal year; and generally relating
9	to appropriations of funds in projects in the Capital Budget for the fiscal year ending
10	June 30, 2022.

15	WHEREAC As Devot of Education Consider Deleted House to society and
16	WHEREAS, the Board of Education Security Related Upgrades capital project
17	(Project No. E538100) and Maintenance Backlog capital project (Project No.
18 19	E538300) have existing appropriations in the Capital Budget for the fiscal year ending June 30, 2022; and
20	ending June 30, 2022, and
21	WHEREAS, Section 716 of the Charter authorizes the County Council, upon
22	request of the County Executive and by affirmative vote of five members of the
23	County Council, to amend the Capital Budget; and
24	County Council, to amond the Capital Badget, and
25	WHEREAS, pursuant to Section 716 of the Charter, upon recommendation of the
26	County Executive, the County Council may make supplementary appropriations to
27	the Capital Budget from revenues received from anticipated sources but in excess

of budget estimates therefor, or from revenues received from sources not 1 2 anticipated in the budget for the current fiscal year; and 3 WHEREAS, additional grant funding in the total amount of \$1,082,000 has become 4 available for the Board of Education Security Related Upgrades and Maintenance 5 Backlog capital projects from the State Interagency Commission on School 6 Construction, which is from a source anticipated in the budget, but in excess of 7 budget estimates therefor; and 8 9 WHEREAS, the County Executive is requesting that the Capital Budget be 10 amended by making a supplementary appropriation to the Board of Education 11 Security Related Upgrades capital project (Project No. E538100) and Maintenance 12 Backlog capital project (Project No. E538300) from the Other State Grants funding 13 source; and 14 15 WHEREAS, in accordance with Section 716 of the Charter, the Planning Advisory 16 17 Board has recommended these amendments to the Capital Budget; and 18 WHEREAS, the Controller has certified in writing that the funds are available for 19 20 appropriation; now, therefore, 21 SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland, 22 23 That the Current Expense Budget for the fiscal year ending June 30, 2022, is hereby amended by making supplementary appropriations to the following capital projects as 24 follows: 25 26 Security Related Upgrades capital project (Project No. E538100) 27 (Other State Grants) \$ 28 782,000 29 Maintenance Backlog capital project (Project No. E538300) 30 \$ (Other State Grants) 300,000 31 32 SECTION 2. And be it further enacted, that the Capital Program and the Capital 33 Projects Bond Ordinance for the fiscal year ending June 30, 2022, are hereby amended in 34
