4	FOR the purpose of allowing modification of the contingent annuitant election for certain
5	retirees in the Fire and Police Pension Plans entering into same sex marriages with the
6	contingent annuitant; and generally relating to pensions.

REDUCTION OF THE PARTICIPANT'S PENSION BENEFIT, AND, ON OR AFTER JANUARY 1, 2013, THE PARTICIPANT MARRIED THE NAMED CONTINGENT ANNUITANT, THEN:

4 5 (1) THE PARTICIPANT'S PENSION BENEFIT SHALL BE RESTORED TO THE FULL BENEFIT; AND

(2) THE PARTICIPANT SHALL BE ENTITLED TO A LUMP SUM PAYMENT OF THE AMOUNT BY WHICH BENEFITS WERE REDUCED BETWEEN THE DATE OF RETIREMENT AND JANUARY 1, 2023.
