3 FOR the purpose of modifying the civil fines for littering; and generally related to crimes,
4 civil offenses, and fines.

6 BY repealing and reenacting, with amendments: § 9-1-703(c)
7 Anne Arundel County Code (2005, as amended)

9 SECTION 1. *Be it enacted by the County Council of Anne Arundel County, Maryland,*
10 That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

11 ARTICLE 9. CRIMES, CIVIL OFFENSES, AND FINES

12 TITLE 1. CRIMES

13 9-1-703. Littering.

16 (c) **Violations.** A person who violates any provision of this section is subject to:

18 (1) a civil fine *[[for a Class D civil offense]]* IN THE AMOUNT OF \$250 FOR THE FIRST
19 VIOLATION, \$750 FOR THE SECOND VIOLATION, AND \$1,000 FOR THE THIRD OR ANY
20 SUBSEQUENT VIOLATION, AND ALL APPLICABLE PROVISIONS OF § 9-2-101 OF THIS CODE;

24 (2) the penalties set forth in § 10-110 of the Criminal Law Article of the State Code.
