3	FOR the purpose of modifying the civil fines for littering; and generally related to crimes,
4	civil offenses, and fines.

6	BY repealing and reenacting, with amendments: § 9-1-703(c)
7	Anne Arundel County Code (2005, as amended)

9	SECTION 1. Be it enacted by the County Council of Anne Arundel County, Maryland,
10	That Section(s) of the Anne Arundel County Code (2005, as amended) read as follows:

12	ARTICLE 9. CRIMES, CIVIL OFFENSES, AND FINES

14	TITLE 1. CRIMES

16	9-1-703. Littering.

18	(c) Violations. A person who violates any provision of this section is subject to:
19	(1) : 11 C FEC CI D : 11 CC 11
20	(1) a civil fine [[for a Class D civil offense]] IN THE AMOUNT OF \$250 FOR THE FIRST
21	VIOLATION, \$750 FOR THE SECOND VIOLATION, AND \$1,000 FOR THE THIRD OR ANY
22	SUBSEQUENT VIOLATION, AND ALL APPLICABLE PROVISIONS OF § 9-2-101 OF THIS CODE;
23	or
24	(2) the manulting set fouth in \$ 10,110 of the Criminal I ary Article of the State Code
25	(2) the penalties set forth in § 10-110 of the Criminal Law Article of the State Code.
