17	1. BE LOCATED IN ITS ENTIRETY WITHIN 1,100 FEET OF THE
18	FURTHEST PEDESTRIAN ACCESS POINT TO THE PARKING LOT OF THE FALLS
19	ROAD LIGHT RAIL STOP; AND
20	2. BE LOCATED WEST OF FALLS ROAD.
