The 2021-2022 Current Expense Budget
Gifts and Grants Special Revenue Fund
MTA – Coronavirus Response & Relief Supplemental Appropriations ACT (CRRSAA)
Operating Assistance Grant

FOR the purpose of amending the 2021-2022 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the State of Maryland Department of Transportation.

WHEREAS, the State of Maryland has made an award of federal funds available to the Baltimore County Department of Public Works and Transportation, to be used to increase the ridership of County Ride, by improving technology, communications and through removal of language barriers to increase equity of ridership; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County
Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County
Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue
Fund and expend the same, said fund having been established solely for the purpose of
accounting for certain monetary gifts and grants made available to the County for restricted
purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore
