A BILL  
ENTITLED

AN ACT concerning

The 2021-2022 Current Expense Budget  
Gifts and Grants Special Revenue Fund  
EDA Revolving Loan Fund

FOR the purpose of amending the 2021-2022 Current Expense Budget, by  
appropriating to the Gifts and Grants Special Revenue Fund monies derived from  
repaid principal funds plus interest and fees.

WHEREAS, in FY 2021 the U.S. Department of Commerce – Economic  
Development Administration made an award of funds (“EDA grant”) to the Baltimore  
County Department of Economic and Workforce Development (“DEWD”) in the amount  
of \$1,628,000, to be used to provide loans to small businesses; and

WHEREAS, as loan payments are collected, the EDA Grant requires DEWD to  
continue to lend the amount of principal repayment, plus interest and fees; and

WHEREAS, the amount of \$59,000 in principal repayment, plus interest and fees,  
is available to lend as of April 1, 2022; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1           SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF  
2   BALTIMORE COUNTY, MARYLAND, pursuant to the power and authority conferred  
3   upon it by Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-  
4   102 of the Baltimore County Code, 2015, as amended, that the Current Expense Budget  
5   for the fiscal year ending June 30, 2022, be and is hereby amended by appropriating  
6   repaid principal funds plus interest and fees associated with federal funds made available  
7   to the Baltimore County Department of Economic and Workforce Development, in the  
8   amount herein specified, to the following program:

10          SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been  
11   passed by the affirmative vote of five members of the County Council, shall take effect  
12   June 19, 2022.
