# A BILL ENTITLED

#### AN ACT concerning

Zoning Regulations - Uses Permitted in the Business, Major (B.M.) Zone

- FOR the purpose of permitting sales of used automobiles and adjoining outdoor sales area under certain circumstances in a Business, Major (B.M.) Zone; and generally relating to uses in the B.M. Zone.
- BY repealing and re-enacting, with amendments

Section 233.1.B, the permitted use "New automobile sales facility and adjoining outdoor sales area, provided that dismantled or junked cars unfit for operation on the highways may not be stored outdoors" listed alphabetically

1	SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2	COUNTY, MARYLAND, that the Baltimore County Zoning Regulations read as follows:

4	ARTICLE 2 - ELEVATOR-APARTMENT RESIDENCE ZONES,
5	RESIDENTIAL-OFFICE ZONES, OFFICE ZONES, BUSINESS ZONES,
6	MANUFACTURING ZONES AND DISTRICTS
7	Section 233 - Business, Major (B.M.) Zone Use Regulations
8	
9	§ 233.1. Permitted uses.
10	The following uses only are permitted (Section 233.2):
11	B. New OR USED automobile sales facility and adjoining outdoor sales area,
12	provided that dismantled or junked cars unfit for operation on the highways may not be stored
13	outdoors, AND ALSO PROVIDED THAT A USED AUTOMOBILE SALES FACILITY MAY
14	ONLY BE LOCATED WITHIN ONE MILE OF THE MIDDLE RIVER DESIGN REVIEW
15	PANEL AREA.

17	SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
18	the affirmative vote of five members of the County Council, shall take effect on July 19, 2022.
