ENTITLED

AN ACT concerning

The 2022-2023 Current Expense Budget
Gifts and Grants Special Revenue Fund
Continuum of Care

FOR the purpose of amending the 2022-2023 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the U.S. Department of Housing and Urban Development (HUD).

WHEREAS, HUD's Baltimore regional Field Office for Community Planning and Development, requested, and the Baltimore County Department of Housing and Community Development (DHCD) agreed to accept, an allocation of Continuum of Care (CoC) funds to provide rental assistance and supportive services to eligible households, such funds having been

previously awarded to a non-profit organization that is no longer able to perform their obligations under their HUD CoC grant; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306
3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County
4 Code, 2015, as amended, that the Current Expense Budget for the fiscal year ending June 30,
5 2023, be and is hereby amended by appropriating federal funds made available to the Baltimore
6 County Department of Housing and Community Development, in the amount herein specified, to
7 the following program:
