County Executive – Compensation

FOR the purpose of increasing the compensation of the County Executive for the term of office to begin in December 2022; and generally relating to the compensation of the County Executive.

BY repealing and re-enacting, with amendments

Section 3-1-102(a)  
Article 3 – Administration  
Title 1 – The Executive Branch

WHEREAS, the Personnel and Salary Advisory Board has recently made a  
recommendation regarding the compensation to be paid to the County Executive; now, therefore,

SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
COUNTY, MARYLAND, that the Laws of Baltimore County read as follows:

#### ARTICLE 3 – ADMINISTRATION

##### Title 1 – The Executive Branch

§ 3-1-102.

(a) Beginning on the date in December [2014] 2022 that the County Executive qualifies  
as provided in § 402(a) of the Charter, the annual salary of the County Executive shall be  
[\$175,000] \$192,000.

SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by  
the affirmative vote of five members of the County Council, shall take effect 15 days after its  
enactment.
