FOR the purpose of amending the 2022-2023 Capital Budget, by appropriating to the Capital Budget Monies derived from state funds and made available to the County from the Maryland Department of Transportation.

WHEREAS, in accordance with Section 716 of the Baltimore County Charter, the County Council may, upon recommendation of the County Executive, amend the Capital Budget; and

WHEREAS, the Maryland Department of Transportation has awarded state funds to the Baltimore County Department of Public Works and Transportation, to be used to fund a

feasibility study of a trail connection at the current terminus of the Torrey C. Brown Trail to the Jones Falls Trail in Baltimore City; now therefore

1           SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE  
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Section 716  
3 of the Baltimore County Charter, that the Capital Budget for the fiscal year ending June 30,  
4 2023, be it hereby amended by appropriating state funds in the in the amount herein specified, to  
5 the following program:

7           SECTION 2. AND BE IT FURTHER ENACTED, That this Act having been passed by  
8 the affirmative vote of five members of the County Council shall take effect October 16, 2022.
