ENTITLED

AN ACT concerning

The 2022-2023 Capital Budget
CC218100 Countywide Improvements

FOR the purpose of amending the 2022-2023 Capital Budget, by appropriating to the Capital Budget Monies derived from state funds and made available to the County from the State of Maryland.

WHEREAS, in accordance with Section 716 of the Baltimore County Charter, the County Council may, upon recommendation of the County Executive, amend the Capital Budget; and

WHEREAS, the State of Maryland has awarded state funds to the County Executive and County Council, to provide a grant to the eligible subgrantee Impact Baltimore EDC for the acquisition, planning design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of the Impact Baltimore Family Enrichment Center; and

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Section 716
3 of the Baltimore County Charter, that the Capital Budget for the fiscal year ending June 30,
4 2023, be it hereby amended by appropriating state funds in the in the amount herein specified, to
